With reference to minutes of proceedings of Council on 7th September 1908, on which date it was decided to acquire a plot of ground at Distillery Road in order to provide housing accommodation for the working classes, a Deed of Conveyance was produced. This Instrument conveyed from the Community of the Christian Brothers at Wexford their interest as Beneficial Owners of the plot in question to the Council to hold such i nterest for ever in consideration of the payment of a sum of £450 to the said Community.

Thereupon the Deed was duly executed on the part of the Corporation.

The question of obtaining tenders in respect of the proposed erection of 22 houses

on the above plot was Cised Wexford Borough Council a Clerk of Works in connection with the impending building operations, but the

consideration of them was deferred for the present.

an application from Dr. Thomas pierse for an increase of his salary as Medical Officer of Health of Wexford Urban District, was read. The present salary was £16. a year, which, Dr. pierse submitted, was entirely inadequate considering the responsibility and many duties he had to perform. He had as much work to perform as any other Medical Officer of Health in any provincial town in Ireland. In Lisburn the Medical Officer of health had a salary of £30 a year, in Sligo it cost the Urban Council £45 a year for two Officers, and in Lurgan £60 a year for one. He called attention to the fact that since the death of the late Dr. Crean the office of Consulting Sanitary Officer for Wexford urban District had lapsed by reason of which the responsibility devolving on him was doubled. In these circumstances he appealed to the sense of justice of the Council to raise the salary to a sum commensurate with the duties.

Thereupon Councillor Hanton proposed that the salary of the Medical Officer of Health be increased by fifteen pounds a year.

The reason the proposer assigned for setting down the increase at this sum was because it was equal in amount to the salary attached to the abolished office of Consulting Sanitary Officer.

The motion was seconded by Councillor Carty.

Alderman Tyghe proposed an amendment to the foregoing motion in the following terms.

That the words "fifteen pounds" be struck out of the resolution, and the words

"fourteen pounds" be inserted instead.

The object of proposing this amendment was to bring the salary up to an even sum of thirty pounds a year.

The amendment was seconded by Councillor prendergast, but on being put was lost, only five members voting for and twelve against it.

The original motion was then put and carried.

An application from Edward Byrne, Sanitary Sub Officer was read. The applicant had been in the employment of the Corporation for eight years at a salary of £40. a year. He had done his duty to the best of his ability and ventured to hopehe had given satisfaction therein. The salary was much below the value of the serwices rendered. He felt assured the Council would take his case into favourable consideration and give him such an increase of salary as might appear to them to be reasonable.

Councillor O'Connor proposed that the application be granted and the salary increased

Councillor O'Connor proposed that the application be granted and the salary increased by £12. a year.

The motion was seconded by Counciller Browne, and on being put to the meeting was carried.

The following resolution on the motion of Councillor prendergast, seconded by Councillor Clancy was adopted.

That a fee of sixpence per case be in future paid to the Town Sergeant for serving summonses in all prosecutions brought under the Towns Improvement Act before the local Borough Court, so as to put him on a footing of equality in respect to his services at this Court with hi Grewexford Borough Council

The following resolution, proposed by Councillor Clancy, and seconded by Councillor McMahon, was passed.

That such of the streets of the town lying between Wygram place and Broad of the Faythe as are not already provided with bi lingual name plates, be furnished with cast iron name plates bearing Irish and English wording, but that this work be carried only so far as an outlay of £5. will admit.

It was announced that the Finance & Works Committee had had before them a letter from Messrs P. J. O'Flaherty & Son, Solicitors, acting in behalf of John Bolger of Courtclough, Blackwater. This letter, besides containing unfounded charges against the Council of partiality in the matter of accepting tenders in connection with the erection of dwelling houses, also contained an intimation that Mr. Bolger would not perform the work of laying footpaths for which work he was declared contractor on 10th November 1909.

Having regard to this latter fact, attention was drawn, by the receipt of a latter from John Browne contractor for the work of erecting two houses at Carrigeen, to the immediate necessity of removing a rock existing at the point where the footpath was proposed to be laid. He (Mr. Browne) was ready to put in the foundations of the two houses, and it was essential that any blasting operations required should be completed previous to the front wells being erected. Under these circumstances he was prepared to do the work of laying the footpath, which involved the removal of the rock, for a sum of £33. This sum was the price which he had offered to accept on loth November 1909 in respect of laying the footpath in question. It was seen that Mr. Browne's tender for this work was the next lowest in amount to the amount of Mr. Bolger's tender, and also was £3. 14. 6 below the amount of the Town Surveyor's estimate.

Thereupon on the motion of Alderman Stafford seconded by Alderman Hadden, it was resolved to accept Mr. Browne's offer to lay the footpath in consideration of his being paid a sum of £33.

Amongst the liabilities was a Rill of Costs from the Carporation Solicitor for legal C: Wexford Borough Council services rendered by him within the previous twelve months. The Solicitor claimed

payment of a sum of £98. 14. 4. This included an item of £55 which he claimed as his legal fee for services in connection with a Mortgage Deed of £7,000 from the Corporation to the Board of Public Works. The Bill of Costs had been hitherto under the consideration of the Finance & Works Committee on two occasions. The Committee were of opinion that the charge in connection with the Mortgage was excessive, and decided to ask Mr. O'Connor to reduce it to £35. This request he refused stating that he preferred to submit the Bill for taxation, more especially as the sum of £55, was the fee laid down by the Solicitors' Remuneration act for legal work in connection with a Mortgage Loan of £7,000. A letter from the Department of Agriculture &c. in Ireland dated 16th December 1909 No. 39542, was read intimating that an Officer of the Department had recently obtained three samples of butter in the Borough for analysis. The samples were submitted to the public Analyst and they proved to be pure.

The local Inspector of Food and Drugs, Acting Sergeant Donaghy, furnished a report. It appeared he had prosecuted at petty Sessions on 22nd. Instant, one Edward Breen, farmer, of Kingsford, for selling a sample of buttermilk contrary to the provisions of the Food and Drugs Acts. The Fiance and Works Committee made a report to the effect that they had received intimation from Mrs Anne Kingsberry that she had recently succeeded to sime property and therefore desired to resign the post of Caretaker of the Town Hall. In view of this fact the Committee had considered the time opportune to revise the rate of remuneration hitherto paid the Caretaker, as it was contended that the wage of 4/- a week which attached to the position should not be continued, having regard to the

other pecuniary advantages derived therefrom.

C: Wexford Borough Council

The Committee therefore recommended that the resignation should be accepted, and that

a man to act as Caretaker should be appointed who would be entitled to the free use of the domiciliary portion of the Town Hall and would receive a bonus of 10% on the receipts from lettings, as well as a fee of 2/6 for each night when the Hall would be occupied up to 10 o'clock, or a fee of 10/- when it would be used all night; these fees, in addition to the rent, to be lodged by those hiring the Hall with the Town Clerk.

It was also recommended that only a man and his wife, or a brother residing with his sister should be eligible for the appointment, which should be made on Wednesday, 23rd. Instant.

Alderman Hughes proposed that the above recommendations be adopted.

This was seconded by Councillor Byrne and was carried.

Alderman Tyghe dissented as he considered the stipend of 4/- should still continue to be paid.

The Local Government Board, by letter dated 21st january 1910, No.150,414/1909, which was read, expressed approval of the increase in the salary of Dr. Thomas Pierse as medical officer of Health of Wexford Urban District from £16, to £31. a year.

A communication from the Irish Financial Reform Committee under date of 5th Inst.

was read. This was to the effect that owing to the increase of Irish taxation

contemplated by the parliamentary Budget Bill soon to be re-introduced, more

especially in regard to the land taxes, the above named Committee had again been

called into existence with a view to bringing the whole question of the over

taxation of Ireland again before Parliament. On a previous occasion petitions

against this financial injustice had been adopted by almost every Public Body in

Ireland, including the Wexford Corporation, and the Committee wished to know whether

the Corporation would be prepared to follow a similar course at the present juncture

The meeting decided to take no action in this matter for the present.

The Manager of the Independent Newspapers Ld. drew attention by letter to the fact that there had recently been placed on the Statute Book the Health Resorts and Watering Places (Ireland) Act, 1909. The effect of this Act was to permit the Council to expend a sum not exceeding in any year the amount realized by a rate of one penny in the pound in advertising the town as a health resort, and if it was contemplated to take advantage of the provisions of the Act, the Independent Co. were prepared to place their services at the disposal of the Council in preparing a scheme of advertising suitable to Wexford.

This matter was referred to the Finance and Works Committee to be dealt with as thought fit.

Councillor Prendergast drew attention to a matter which he considered called for remedy, namely the increasing difficulty which the Rate Collectors experienced in collecting rates as seed: Wexford Borough Council and the Working Classes Acts. By Section 53 (1 of the Local Government (Ireland) Act 1898

it was incumbent on occupiers of dwellings to be assessed for all rates leviable in the district, and this practice had been followed since the passing of the Act in the case of the occupiers of the working class dwellings above referred to. The Collectors however, in some instances found that when rates were demanded the tenants vacated these houses leaving the rates unpaid, and in such cases it had been found impossible to recover them. Councillor Prendergast suggested the advisability of increasing the rents per week by a sum which at the end of each financial year would produce, as near as may be, the amount assessed on the dwellings as rates, and so follow the custom which was universal throughout the town in the case of weekly tenants.

With regard to the order appearing on the minutes of last meeting, as to the Town Hall being given free of all charge in certain cases, it was decided to strike such order off the minutes of the day's proceedings as being the result of a misconception.

With reference to minutes of 7th February last, on which occasion a proposal was entertained as to the advisableness of the Council paying local rates on all houses in the town erected under the Housing of the Working Classes Acts, a tabular statement was submitted showing what the items of rate chargeable on these houses came to in an average year in each individual case. According to this it was seen that if the proposal were carried into effect, and at the same time that no consequential loss to the Corporation Funds should be permitted to arise, it was necessary to increase the rents of each of 72 of the dwellings by threepence per seek, but in the case of the seven larger-sized houses at Monument place, an increase of fourpence per house per week was necessitated. It was also apparent that an all-round increase of threepence per house per week would involve no loss but on the contrary a slight pecuniary advantage would accrue to the Council. The matter was given due consideration. It was urged that the contemplated step, although at variance with the principle of the Statute, was nevertheless justified by the circumstances. Accordingly a motion was given and accepted from Councillor Prendergast to the effect that he proposed to move at next Statutary Meeting that an increase of threepence per week per house be made in the rents of the dwellings in question, and as a quid pro quo to the occupiers that all the items of rates leviable thereon be paid out of the Municipal Coffers.

Attention was drawn to the provisions of the Cinematograph Act, 1909, and the Regulations thereunder made by the Lord Lieutenant under date of 21st january 1910. The Enactment provided for the licensing of premises wherein cinematograph exhibitions were permitted to be carried on, and for the apparatii to be of a certain construction and used under restrictions so as to ensure safety.

The matter was referred to the Finance & Works Committee to deal with as thought well.

with reference to minutes of proceedings of 7th February kast, and of the 7th March last, the following motion, proposed by Councillor Prendergast(pursuant to motion given by and accepted from him on the last-mentioned date) was seconded by Councillor McMahon and adopted unanimously.

With reference to Resolution passed on 11th may 1910, a communication from the Home Office was read intimating that the Resolution of Condolence of the Borough of Wexford on the death of his late Majesty, King Edward the Beventh, had been laid before queen Alexandra, whose thanks was conveyed to the Council through the Mayor. A letter was read from the Secretary of the Commissioners of national Education, under date of 4th May 1910. He pointed out that the pariod of service of the School Attendance Committee for Wexford Urban District was due to terminate on 31st. July 1910, and that it was necessary that a fresh Committee should be appointed for the three years commencing 1st August 1910. The number of members to form the Committee was ten, five of whom were to be appointed by the urban Council, and the other five by the Commissioners of National Education.

It was announced in connection with this matter, that the five members serving on this Committee as appointed by the Council at the present time were Councillors

Rowe, Kelly, Hore, Prendergast, and Alderman Stafford. Councillor Kelly then stated that he wished his name not/be included in the list of the new Committee as he did not wish to serve as a member of the Committee any longer.

Thereupon on the motion of Councillor Hanton Seconded by Councillor Carty it was resolved that with the exception of Councillor Kelly the above-mentioned be reappointed, and that Councillor O'Connor be added to the Committee viceCouncillor Kelly.

It was reported that two of the thirtynine houses which were being provided under the Housing of the Working Classes Acts had been finished in Carrigeen and were ready for habitation. The Finance and Works Committee had inspected them on the 2nd. Instant, and charge of them had been taken over from the Contractor, and at the present juncture it was necessary that the terms of letting should be determined.

From a computation which was presented to the meeting it was seen that the capital

A report of Mr. J. A. Baker, Local Government Auditor, on the Municipal Accounts for the financial year ended 31st march 1910 was read. It was accompanied by an Abstract of the Accounts duly certified. It was seen that a payment of £90 was paid to Mr. O'Connor, Solicitor, in settlement of a Bill of Costs amounting to £96. 5. 8. The Auditor was unable to allow this payment as the costs were not taxed, and in order to permit of a taxation being made, he had deferred dealing with the matter until next audit. The Bill included an item of £55 being fee in connection with a Loan of £7,000 from the Commissioners of Public Works in respect of which a sum of £7,000 from the Commissioners of Public Works in respect of which a sum of £7,000 from the Commissioners for perparation of the Mortgage Deed, and the inclusion of the charge of £55 in the Bill of Costs therefore

required to be substantiated.

Regarding this matter it was ordered that the Town Clerk be directed to write to the Local Government Boardrequesting the Board to approve of payment of the £90 in question, pointing out with regard to the impugned item of £55 that the Council requested their Solicitor to abate his demand but without avail, as he cl aimed that sum as his legal fee in the case pursuant to the Solicitors Remuneration Act. Moreover it was directed that the attention of the Local Government Board should be directed to the fact that assuming the fee of £55 to be legally payable to the Solicitor, the Council had by their action obtained a reduction in the amount of the Bill of £6. 5. 8 in addition to which they had effected a saving of £5 by waiving their right to having the Bill taxed.

A passage in the Report ran as follows:-

"I had occasion in my last reprt to refer to the fact that there was no guarantee bond for the Town Clerk's Assistant, Mr. N. Bolger, as he is not directly paid by the Corporation. Having regard to the fact that considerable sums pass through his hands it might be desibable for the Corporation to consider whether his long, and i believe satisfactory service, would not entitle him to official recognition requiring the usual guarantee." The question was referred to the Finance & Works Committee for consideration. The Technical Instruction Committee recommended that a person should be appointed to serve as a member of the Committee in room of Mr. M. A. Ennis who had resigned, as was seen by a letter received by their Secretary from that gentleman. The resignation had been accepted by the Committee with much reluctance, and the Council decided to act on the recommendation. Committee, stated by letter the terms on which the Company were prepared to maintain and light the public lamps in the town if, as was suggested, the lighting period was re-arranged.

The terms were as follows.

- (a) The charge for lighting all the year round, no advantage to be taken of the moonlight nights would be £3. 11. 6 per lamp.
- The charge for lighting in the same way from 15th August to 15th May would be £2. 16. 6 per lamp.
- (c) Or the lamps would be lighted all the year round, with the right to commence extinguishing at ten o'clock on moonlight nights for two nights before Full Moon, the night of Full Moon, and at eleven o'chock and later on succeeding nights in accordance with the time of moonrise for £3. 4. 6 per lamp.
- (d) Or to be lighted all the year round, but advantage to be taken of the Moonlight nights as at present £2. 15. 6 per lamp.

The question evoked considerable discussion which resulted in the adoption of the following resolution, as proposed by Councillor Kelly and seconded by Councillor Prendergast.

That a Committee consisting of The Mayor, Aldermen Hadden and Stafford, and Councillors Hanton, Kelly, and Hore be appointed to consider the question and report thereon.

The question of re-appointing an Officer as Veterinary Surgeon under the Dairies, Cowsheds, &c. Order, 1908 was considered. The year for which the office was established was due to expire on 7th September next, and it was at the present time opportune for the Council to determine whether the office was to be continued and if so the period of such continuance. Some of the members present urged the abolition of the office, and the following motion, as proposed by Councillor Hanton and seconded by Alderman Hughes met with opposition, but was nevertheless carried on a division viz: .

That the Office of Veterinary INspector to the Council be continued for one year longer from 7th September next.

An outbreak of fire which took place on the night of 30th July Ultimo, at the Works of Messrs Pierce & Co., manufacturers of cycles and agricultural impliments, was made the subject of a communication received from Mr. Joseph S. Thompson, Captain of the Wexford Volunteer Fire Brigade. Mr. Thompson drew attention to the serious danger that existed through the want of a quick and certain means of conveying alarm of fires, first to the members of the Fire Brigade, and then to the Officials of the Council who had charge of the main valve in the event of the water being shut off at night. The fact that there was notelephone communication between the two Police Stations led to delay, misunderstanding, an Con Wexford Borough Counciled of the town took an unnecessarilylong time to reach the other end. The question of

protection and regulation of the crowd by the Police in the case of a big fire was a vital one. On the occasion in question the multitude were allowed to throng the passages and interfere with the hose, so that the efforts of the Brigade were seriously encumbered.

The Communication was referred to the Finance and Works Committee to deal with as they thought fit.

A communication from the Local Government Board, under date of 14th July 1910, No.41,839, was read. It contained extracts from the Medical Officer8s Return, Form L, for the half-year ended 31st march 1910. The Return showed that the water supply to the Urban District was good, but was capable of being improved by filtration and that pigs were kept too near dwellings in some of the poorer localities.

The contents of the Return were noted.

A communication from the same Department under date of 25th July 1910, No.48,365, was read. It referred to the Trade Boards Act 1909. it was seen on reference to the copy of the Act which accompanied the communication that the Enactment applied only to trades at present set out in the Schedule thereto.

So far, Wexford was not affected by the Act and there was no action taken.

The introduction of this matter gave rise to some comments on the present strength of the Fire Brigade, having regard to the belief generally entertained that the Brigade was not sufficiently strong in numbers to cope with the unpresedentedly large conflagration which broke out on the premises of Messrs Pierce & Co. on the night of 30th July last.

Thereupon it was ordered. That the Finance and Works Committee, with the assistance of Mr. Thompson, be requested to take the question of enlarging the list of members of the Fire Brigade and the expediency of providing any service appliances needed into consideration on an early date.

An official notice was read from Messrs p. J. O'Flaherty and Som, Solicitors for the Wexford Gas Company, containing notification of the intention of the Company to apply to the Board of Trade for approval of the use, for testing gas under the Wexford gas Order, 1903, of a new testing burner known as the Metropolitan Argand No. 2 instead of Sugg's London Argand No. 1 as specified in Clause 28 of the said Order, and furthermore that it was open to the Muncipal Council if they conceived any ground for objection to the use of the substituted burner to make representations to the Board of Trade within a specified time.

A letter which accompanied the notice contained an explanation of the object of the Company in making the application. This was to obtain a burner that was designed to give, nearly as it was at present possible, the true illuminating value of the gas tested, and as the use of this burner had been sanctioned for several cities and towns in England, and the Dublin Gas Company in Ireland, the Wexford Company considered they were entitled to employ the same make of burner. This explanation was very good so far as it went, but there was nothing to show whether, and if so how far, the interests of gas consumers would be affected by the proposed alteration. The question was a technical one and required for its solution the light of expert knowledge.

Thereupon on the motion of Alderman Hadden, seconded by Councillor prendergast,

It was Resolved:) That the services of a gas tester be engaged to advise the

Council as to the proper course for them to follow in the matter and pending the

receipt of expert advice that notice of objection be served on the Board of Trade

so that the Council might be in a position to follow up the objection if necessary

It was ordered: - That the Waterworks Committee be requested to meet on a convenient day and proceed by car to Coolree Reservoir on a visit of inspection.

Attention was drawn to the minutes of proceedings of loth November 1909, on which occasion there were received and opened two tenders in respect of the construction in Grogan's Road and Carrigeen two adjoining streets, of a concrete footpath.

The necessity for this work was consequent on the erection in the locality named of fifteen dwellings for the housing of the working classes. The two tenders were from Mrs. mary O'Connor, Builder, and John Bolger, Courtlough. The former offered to do the work in consideration of being paid £61. 15. 0, and the latter £15. 9.0. which offer was accepted. Subsequently Mr. Bolger refused to do the work or enter into a contract in respect of doing it, vide minutes of 6th December 1909. The dwellings were now approaching completion and the time had arrived when it was necessary to proceed with the laying of the path and the mestion for consideration was would Mrs O'Connor, who it was announced was still satisfied to abide by

her offer, be employed to have the work done at the price named by her, especially as the disparity in the prices was enormous. Hereupon the Town Surveyor stated that his estimate of the cost showed that the work could not be done for less than £57, and having regard to this fact it was proposed by Alderman Hadden that Mrs O'Connor's tender be accepted.

The motion was seconded by Councillor Doyle and was carried unanimously.

Two tenders were received in respect of supplying twelve form s to enlarge the seating accommodation of the Town Hall. They were from Walker, Beary & Co., who undertook to supply the articles at a cost of £6. 5. 0, and willian keane who was prepared to supply them at a cost of £7. 4. 0.

The lower tender was accepted.

A communication from the urban Council of Ballinasloe showed that that Body was desirous of having the provision of the Local Government Act, 1898 regarding the rating of houses under £4. valuation amended. The object in view was to make the owners of these houses liable for the rates as they were before the passing of the Act because of the difficulty of recovering rates from occupiers of houses let to weekly tenebts.

"Whenever the net annual value of the whole of the rateable hereditaments
liable to be rated for poor Rate occupied by any person or persons having no
greater Estate or interest therein than a tenancy from year to year shall not
exceed four pounds, the poor rate in respect of such property shall be made on
the immediate lessor or lessors of such person or persons, and such lessor or
lessors shall for the purpose of the poor Relief (Ireland) Acts, 1838 to 1862,
and the enactments amending or incorporating the same be deemed to be the
occupier or occupiers of the said hereditaments, and if at the time of making
any rate the name of the immediate lessor be not accurately known to the person
making the rate, it shall be sufficient to describe him therein as 'the immediate
lessor' with or without any name or further addition, and such rate shall be
held to be duly made on him by such description and shall be recoverable from
him accordingly notwithstanding any error or defect in his name or description
or the entire omission of his name therein."

The matter was considered and on the motion of CoUncillor Kelly seconded by Councillor Hore it was decided to make an effort to bring about the amendment through Parliamentary action.

The Hon. Secretary of the Wexford Lecture Association communicated by letter the terms of a resolution adopted by the Association as follows

The Mayor took the opportunity of the assembling of the present meeting to call attention to the death, on the 6th Instant, of the late Alderman John Tyghe. He paid a graceful tribute to the memory of the deceased and said that were it not for the fact that the business for which the meeting was convened admitted of no delay he was prepared to suggest the postponement of the meeting as a mark of sorrow for the loss of a revered and valued member of the Council.

Under the circumstances he proposed that an expression of condolence in behalf of the Council be sent to Mrs Tyghe and her family on the sad event which had taken place.

The motion was seconded by Alderman Hughes and was passed unanimously.

The expediency of opening a new road within the town from John Street to St. peter's Road at Airhill was then taken into consideration. The question was one on which the ratepayers as well as the Council had been given ample opportunity to make up their minds such as the importance of it demanded, it having been before the Council on five de in Wextor cha Borought Council anuary 1908, 3rd. February 1908, 2nd. march 1908, and 7th June 1909. On the last-mentioned

date a Committee of the entire Council was appointed who reviewed former Committee reports and made further enquiries. As a result of their labours they had come to the conclusion that the necessity for the road was real and urgent and they had formulated a Scheme under which the opening of the raod could be carried out to the best advantage and which they strongly recommended to the favourable consideration of the Council. The scheme comprehended the acquisition of a quantity of land and three houses, the estimated compensation for which would not exceed £3470; the construction of the road in the manner previously contemplated at an estimated cost of £2500, and the obtainment of a Provisional Order, necessitated by the fact that some of the Occupiers and Owners refused to sell their interest in their lands, at a cost not exceeding £300, making in all £6270. As the road would run through lands naturally adapted to the purposes of desirable building sites, the quantity of land to be taken was to far exceed the quantity absolutely required for the construction of the road proper, but the surplus land was to be sold as occasion offered as sites for residences, except a portion on the north side which was to be specially reserved for any purpose which the Council might, at any future time, settle on. The question was deliberated on at great length. There was a difference of opinion as to the need for the undertaking, and considerable opposition was evinced towards it. Those in favour of it endorsed the views of the Committee on every point, while the arguments against professed to show that the figures detailed in the estimate were not well-founded and were altogether below what they should be. According to many

Thereupon the following motion, as proposed by Alderman Hadden and seconded by Councillor was put to the meeting, viz:-

of the opponents the cost could not be less than £10000.

That this meeting hereby authorizes the acquisition by the Council of certain plots of land lying between John Street and St. peter's Road as delineated on the maplof said lands containing Fourteen Acres, One Rood, and Seven Perches in the aggregate, together with three dwelling-houses in John Street to permit of the opening of a new road, and also to allow of the provision of a number of much-needed building sites adjoining such road, and for other purposes which may be hereafter specified, and in order to accomplish the object in view that our Solicitor be instructed to take such steps as may be necessary to obtain a provisional Order to secure the fee simple estate in possession of the said lands for the purposes aforesaid. The meeting assembled to take into consideration a Report from a Deputation from the Finance & Works Committee containing the terms on which it was possible for the Council to come to an agreement with the Wexford Gas Company in virtue of the Council withdrawing opposition to the proposal of the Company to seek powers from the Board of Trade to repeal Clause 28 of the Wexford gas Act so as to allow of the Company using a modern design of burner in connexion with their gas testing apparatus.

The Committee had been fortified with the advice of Mr. Henry F. Cotton, City Gas Engineer, Dublin, whose assistance was called into requisition by virtue of resolution of the Council of 3rd. October Ultio. This gentleman had furnished two reports, one previous to an interview between the Deputation and the Manager of the Gas Works, and a supplementary one subsequent to the interview.

The Board of Trade had been served with notice on behalf of the Council, specifying that in reference to the application of the Gas Company in the matter, the Council had intended to make certain representations. These were set out as shown under the following headings, and were based on Mr. Cotton's advice.

- 1. That the said Company shall supply and fix free of charge to each slot meter consumer one complete incandescent burner ready for use.
- 2. That the Company shall, on application supply and fix free of charge a sufficient number of flat flame burners suitable for use with the new gas in place of any burners not being incandescent burners, used by the consumers at present.
- 3. That the said Company will guarantee to maintain a Standard Calorific Value which shall not fall below 500 British Termal Units per cubic foot, and that the said Corporationshall be empowered to ascertain from time to time the heating value of the gas by use of an approved form of Calorimeter.
- 4. That the Company will agree to adjust the existing incandescent burners to suit the requirements of the new gas on application from any customer.
 - 5. That the price of gas chargeable by the said Company shall be

reduced by at least twopence per 1000 cubic feet, in consideration of the Corporation consenting to the said Company's use of the Metropolitan Argand No. 2 Burner, as by the use of this burner the cost of manufacture will be considerably reduced, and that this reduction be not subject to the terms of Clause 26 of the Gas and Water Clauses Confirmation Act, 1903, in reference to the dividends payable by the Company on a reduction in the price of gas being made.

The Report of the Deputation which was then read set forth such of the points above stated as the Gas Company were prepared to give way on.

They were as follows:-

- 1. To supply free of charge on application, as heretofore, flat flame burners as recommended by Mr. Cotton.
- 2. To adjust, free of charge, the existing incandescent burners to suit the new requirem ents, on application from any consumer.
- 3. To supply, free of charge, on application, to all users of slot meters not already having such, one incandescent burner complete.
- 4. To give a reduction of twopence per thousand in the price of gas to all consumers in the town and to allow a proportionate reduction in the charge for gas to public lamps.

The concluding words of the report ran as follows:-

In view of the substantial advantages thus conceded, the members of the Deputation recommend the Corporation to withdraw their notice of objection to the Board of Trade.

And in concluding his supplementary report, it was seen that Mr. Cotton stated"I might say that I consider the Corporation have got good terms and would not have got better in the interests of the consumers had they gone to Parliament."

The reupon on the motion of Alderman Hadden, seconded by Alderman Hughes, it was RESOLVED:- That the Report of the Deputation be adopted and that the Corporation Solicitor be instructed to notify the Board of Trade of the conditions of settlement of the case, and of the fact that no apposition would be given by the Council to the granting of the Gas Company's application.

A Statement of Account was submitted showing what the Capital and Annual Expenditure was in connection with the erection of 15 of the 39 houses at present being provided under a Scheme formulated under the Housing of the Working Classes Acts, with a view to determining what the weekly rents would be, but it was not considered advisable to go into the latter question pending the receipt of a report from the Finance and Works Committee.

The matter was therefore adjourned to the 16th Instant to allow of the Committee making a report.

A letter was read from the Local Government Board dated 29th October 1910, No.66355 relative to the proposal of the Corporation to obtain a provisional order to enable them to acquire by compulsion certain lands in connection with the making of a new road, &c. as C:dWexford Borougo Council

The Local Government Board pointed out that while the Corporation had power to

acquire so much land as was required for the purpse of making a new road, they could not acquire land for the purpose of selling it again for building sites.

Having regard to the terms of this letter, it was announced that Counsel's opinion had been obtained on the point as to whether the Corporation had any peculiar or exceptional rights under the Wexford Charter of Incorporation to purchase land and dispose of it again as building sites, in as much as the case was exceptional, for the reason that it so happende that all the land through which the read would lie was part of the Ancient Estate of the Corporation, but was in the possession of leaseholders.

The opinion was read, but it afforded no hope that the Corporation were empowered to speculate in land under any comditions, but as the opinion was of a highly technical character, it was referred to the Road Committee for consideration.

The Captain of the Volunteer Fire Brigade applied by letter for additional outfit for members of the Brigade, as the strength of the Corps had been increased by three members, and also for 200 additional feet of canvas hose, together with sundry appliances.

The consideration of this matter was also deferred to the 16th Instant to allow the Captain to come before the Corporation and make a verbal explanation.

With regard to an application of the Wexford Lecture Association for the use of the Town Hall for their winter series of lectures free of charge, the following motion, as proposed by Councillor Carty and seconded by Councillor Hore was adopted:

That the nominal charge of 2/6 per lecture be made on the Association for the use of the Town Hall, together with which they be required to pay 2/6 per lecture as a fee to the Caretaker of the building.

On the recommendation of the Finance and Works Committee it was ORDERED: - That persons engaging the use of the Town Hall in day time as well as at night, be required to pay, in addition to the charge for the Hall, a fee of 2/6 for the Caretaker, this order being made to supply an omission in the rule as to the Caretaker's fees made on 7th February 1910.

Seven of these buildings had been erected at Grogan's Road, and eight of them at Carrigeen, the former being of a larger size than the latter. It was seen that the cost of providing the seven houses at Grogan's Road was £1449. 10. 0 and that the annual expenditure would come to £87. 18. 8, or £12. 11. 3 per house. According to this it was possible to let the houses at a weekly rent of 4/10 per house without causing the ratepayers to suffer any consequential loss. As to the eight houses in Carrigeen the Capital Expenditure was seen to be £1285. 4. 0 and the annual expenditure £77. 16. 5 or an annual expenditure of £9. 14. 7 per house, this permitting each house to be let at a weekly rent of 3/8 without causing any demand to be made on the rates. The Finance and Works Committee made a recommendation on the subject. They were of opinion that the houses were not large enough to command rents above estimated and rather than suffer the Council to run anyrisk of the houses being left idle, recommended that the seven houses in Grogens Road should be let at 4/6 per week, and the eight at Carriguen at 3/3 per week.

The question was considered, whereupon it was proposed by Alderman Stafford, seconded by Councillor McMahon

That the recommendation of the Committee be adopted, and the rents fixed at 4/6 per week in the case of the houses at Grogan's Road, and 3/3 in the case of the houses at Carrigeen.

An amendment to this proposition was moved by Alderman hadden and seconded by Councillor Prendergast, in the following terms

That 4/10 be substituted for 4/6 and 3/2 for 3/3

The rent for the two lines of terephone required was £9. a year.

Attention was called to the necessity for having an additional gas lamp erected in South Main Street and another in Grogan's Road to light the new houses erected there, and another in Talbot Street, and the Lamp Committee was requested to traverse the streets of the town after dark on a convenient night and see where some additional lamps might be put up to the best advantage.

The advisableness of the Gas Company being required to provide a Pressure Gauge at Redmond Road was urged as this locality was situate at one of the lowest levels of the town, but it was pointed out that the Company had been asked on divers former occasions to provide a gage at the point mentioned, but they had refused stating that they were satisfied to erect a Gage at the Town Clerk's Office, which was situate midway between the highest and the lowest levels of the town.

One of the accounts passed this day for payment evoked considerable criticism. It was a sumof £15. 14. 2, and formed the balance of a Bill of Costs claimed by the Corporation Solicitor. The Bill of Costs in question was paid to Mr. O'Connor on the 3rd. January 1910 by way of a compromise. He on his part abated his demand in consideration of the Council foregoing their right to submit the Bill to taxation. This arrangement did not satisfy the mind of Mr. Baker, Local Government Auditor, who entertained doubts as to the legality of one item which alone amounted to £55. As a consequence the Bill was duly taxed, whereupon the Taxing Master had allowed all the items chained restoring the Bill to its original amount. To this was added the cost of the taxation.

was made a subject of comment and was directed to be brought under the notice of the Local Government Board.

A communication from Major Fuge, Labour Exchange Divisional Officer, Dublin, was read. He stated that Wexford Town was one of the Centres selected in Ireland for extensions of the Board of Trade Labour Exchange Scheme, and if an Exchange was desired there it was necessary that written undertakings should be obtained from Employers of labour to support the Institution. By support was meant that in the event of Employers requiring workpeople they would engage them through the medium of the Exchange, and if workpeople also undertook to avail of it it would do much to ensure the success of the Scheme.

Thereupon on the motion of Councillor O'Connor, seconded by Councillor Carty it was Resolved: - That an endeavour be made to have a Labour Exchange opened in the Town at the earliest possible date.

With a view to the object of this resolution being accomplished, a Committee was formed. This was made to consist of the Mayor and Councillors O'Connor, Carty, and Kingsberry,

A leter No. 642, dated the 25th January 1911 from the Local Government Board was submitted. The Board stated with reference to an entry on the minutes of the proceedings of the Council on 2nd. January 1911, that the Council as a Sanitary Authority, should give careful consideration to the question of the filtration of the water supply of the town.

The meeting, taking into consideration that as the water supply was abundant, and of fairly good quality, and as the filtration of it would involve an outlay of several thousands of pounds, deferred thequestion for further consideration. Alderman Hughes by letter tendered his resignation as Representative of the Corporation on the Harbour Board. He insisted on retiring from the Office in order to allow of the ex-mayor, who had taken a deep interest in the administratio of the Harbour Trust, an opportunity to be nominated for the position. He thanked the Corporation for the confidence they had always reposed in him (Alderman Hughes) as their representative.

The resignation was accepted.

The Secretary of the Wexford Branch of the Postmen's Federation requested by letter that steps should be taken to have all the houses in Wexford properly numbered. Much inconvenience was caused to the Postmen by the fact that in some cases more than one house in the one street bore the one number.

This matter was referred to the Town Surveyor with instructions to him to formulate a Scheme of numbering for the consideration of the Finance and Works Committee.

The Wexford County Committee of the Gaelic league brought under notice a resolution which had been adopted by that Body regarding the influx, on Sundays, into the towns of Ireland of what they deemed to be foreign and debasing

generally to check this evil.

A discussion thereupon took place in the course of which the practice in Wexford of selling English Newspapers on the streets on Sunday was animadverted on, but it was pointed out that no power seemed to be vested in the Council to prohibit the sale of literature on the Sabbath. Shops had a right to be kept open for this purpose, and the practice of selling on the streets, which was confined to a few boys, was also permissible. The ex-mayor stated that he had suppressed the reprehensible practice among those boys of crying the papers on Sundays to the annoyance of the inhabitants. There was no cause of complaint on that score. The suggestion then that a Bye Law should be made to prohibit this kind of Sunday trading was not entertained. It was announced that the ex-Mayor had written to Lord Muskerry requesting an extension of the term of the lease of a plot of ground in the Bullring on which the Butter Market was erected, and had received a reply. Lord Muskerry stated he would communiste with Messrs Little & Nunn, Solicitors, and had no doubt that matters would be arranged satisfactorily to permit of the Council erecting the proposed Municipal Buildings.

The public Lamp Committee reported they had traversed the streets of the twon after nightfall and visited localities where it was alleged there was need for additional gas lamps. They had inspected grogan's Road, Talbot Street, Distillery Road, Maudlintown, and Main Street South. They recommended that one more lamp should be erected in each of those streets at points indicated in the report. Touching an existing lamp situate at a point on the boundary line at Maudlintown, the Committee suggested that it should be shifted to the opposite side of the street, or failing that, that it should be raised two feet above the present haight.

Thereupon on the motion of Councillor Prendergast, seconded by Alderman Sinnott, it was Resolved: - That the Report of the Lamp Committee be adopted.

It was Ordered: - That the attention of the Lamp Committee be directed to the necessity for re-arranging the position of a lamp convenient to patrick Squarg, and in Bride Street.

Intimation of the intended holding in Dublin from the 15th to the 21st August 1911 of a Conference of Sanitary Authorities and a Congress of the Royal Institute of Public Health, was afforded by a communciation from the Town Clerk, Dublin, and Sir C. A. Cameron. The subjects for discussion were principally to be Housing of the Working Classes, Town Planning, Disposal and Treatement of Sewage, etc. The Corporation were invited to send Delegates to the Conference and Congress. The following were appointed to attend as Delegates, viz: Alderman Sinnott and Councillors McMahon and Carty.

Relative to the proposal of the Council to obtain compulsory powers to acquire lands for the purpose of making a new road etc., (a subject which was last under consideration on 7th November last) a letter from the Local Government Board (No.78148) dated the 6th January 1911, was read. The Board did the Council the favour to state that there was clearly no way under the existing law in which the Council could purchase land for the purpose of the council could purchase land

The reupon on the motion of Councillor carty, seconded by Councillor Hore, it was

Resolved: That the question of the opening of the proposed road be referred to a Committee of the whole Council

A tender which was received in respect of supplying four outfits for members of the Fire Brigade was submitted, and the question of the irregularity of entertaining it was raised. No tenders had been invited for the present meeting for supplying these articles, but there had been advertisements issued asking for tenders to be furnished in time for the previous Monthly Meeting on 2nd. January last, on which occasion there wasno response to the advertisements. Under these circumstances it was contexted that to consider the tender was a matter of doubtful propriety, and it was proposed by Alderman Sinnott that the tender be not considered, and that fresh advertisements be published calling for tenders to be sent in in regard to supplying the goods required against next meeting.

This motion was seconded by Councillor Gibson, and was passed, but not without a division having been taken, whereupon nine members voted for and eight against the motion.

It was suggested that an effort should be made to have the Mayor of Wexford for the time being appointed a Member of the Committee of management of the County Infirmary and of the Enniscorthy Lunatic Asylum. As the contribution in the form of Poor Rate from the Town towards the maintenance of these two Institutions amounted to a substantial sum, it seemed appropriate that the County Town should be directly represented on these Committees, not to speak of the fact that the inclusion of the mayor in the membership would be an act of grace and courtesy which would be fully recognized and appreciated by the inhabitants of Wexford. Thereupon the Town Clerk was directed to write to the County Council representing to them that it was the views of the Corporation that the standing of the mayor entitled him to a position of membership on the two Committees mentioned. A proposition made by Councillor Clancy and seconded by Councillor McMahon as to changing the time of holding Monthly meetings of the Council from the first Monday of each month at noon to 7. 30 p. m. on the same day, or otherwise to the first Wednesday at 7, 30 was considered.

The motion failed to be carried, as on a division 9 members were against and only 8 in favour of the motion.

In view of an imminent meeting of the Roads Board in Dublin, at which Delegates from Wexford were appointed to attend, the following resolution as proposed by Councillor Carty and seconded by Alderman Hadden was passed unanimously for submission to the Board

"That we the Wexford Corporation protest against the whole South Eastern portion of our County being left out of consideration by the Roads BBard when passing their Trunk Road Scheme, particularly as the road from Enniscorthy to RossMare Harbour via Wexford is so necessary to connect with cross-channel services. If this road is not included we ask our Representatives to have nothing to do with the Scheme, as it would do our Town a serious injury by diverting traffic away from the Capital Town of the County."

A civil Bill issued at the suit of Mrs Johanna Byrne of Bullring Wexford against the Wexford Corporation and the Wexford gas Company jointly was produced. The Plaintiff, claimed payment of £5. being the cost of making good all damage done to the windows of her premises by an explosion of gas which occurred in the street by reason, as was alleged, of the defective manner in which the defendants, or either of them, constructed a sewer in Common Quay Street and laid a gas (main.

In the course of a discussion on this matter the facts were elicited that in consequence of the recent consecutive Borough Counciles ary to take up

portion of a gasmain and relay it. The manhole was maid by the Corporation and the gas main was dealt with by the Cas Company's men. The gas main was laid over the wall of the man hole without sufficient provision having been made for the main to yield in case of heavy pressure from traffic overhead. The consequence was the gas pipe became broken and the leakage of gas into the sewer occurred convenient of a ventilating lamp, and the leakage was attended by the explosion. Thereupon it was ordered:-

That this Council is prepared to negociate with the Gas Company for a settlement of the case without prejudice and is satisfied to pay half the amount of Mrs Byrne's expenses in the matter, and that the gas Committee appointed on the 2nd.

January last be requested to interview the Secretary of the Gas Consumers Company and submit this offer to him.

The question of determining the rents to be charged for 22 dwelling houses at Distillery Road, the erection of which had been lately completed, was considered. The Finance and Works Committee had recommended that these rents should be fixed at 3/2 per house per week. The houses were exactly of the same class and dimensions as eight houses in Carrigeen, the rents put upon which on 16th November last was 3/2 each per week.

The recommendation was adopted.

A communication was read from the Clerk of Athlone Town Commissioners on the subject of rating of Railways in Urban Districts. The Railway Companies throughout the Country contended that nearly the whole of the Railway Buildings were to be assessed as Railways, that was to say upon one-fourth of their valuation only, on the ground that being used mainly in connection with the business of a Railway, such buildings were to be deemed as "land used as a Railway". There did not appear to be the remotest justification for treating Railway Companies more favourably than ordinary Ratepayers in such a matter, and the Athlone Commissioners suggested that the various Urban Authorities should join together in fighting the case to the highest tribunal, or if advised that the Railway Companies' contention was correct under the existing state of the Law, all Urban Authorities should make a strenuous and unanimous effort to bring about an amendment of the Law.

In the course of a conversation on the question, it was pointed out that so far as Wexford Urban District was concerned, the attitude of the Railway Companies in respect of differential rating would cause a reduction of about £50 a year in the Rates assessable on their property. Attention was also called to the fact that the Dublin and South Eastern Company had succeeded in having the valuation of theri premises in Wexford divided by the County Court Judge and had claimed a reduction of three-fourths rating on portion of the premises in Wexford. This claim had been sumbitted to Counsel who gave it as his opinion that the Corporation had no alternative but to yield to the Company's demand. Having regard to these latter facts the following motion was adopted on the motion of His Worship, The mayor, seconded by Alderman Hadden, viz:-RESOLVED:- That this Council is willing to co-operate with the various Urban Councils in Ireland in an endeavour by parliamentary action to have the law amended relating to differential rating in the case of the property of Railway Companies.

Two tenders received in respect of painting the Town Hall were opened. They were seed

- (2) It was necessary to provide Municipal offices, but if the Corporation decided to build them over the market, it was open to them to build without obtaining a fresh lease for the reason that at the end of 59 years any public buildings on the ground would be worth little more than ground value, and moreover, before the lapse of 59 years it was probable that fixity of tenure in towns would be a principle recognized by law.

His Worship was also desired to enquire whether the landlords would be disposed to sell their interest in the ground, out-and-out to the Corporation, and if so, to submit any reasonable offer he thought well of for the purchase, or otherwise, to offer £200 in consideration of the Owners granting a fresh lease for a term of 300 years.

Pursuant to notice accepted at last meeting, from Councillor O'Connor that member C: Wexford Borough Council proposed the following motion.

A letter from Messrs Little and Nunn was read on a subject which was under the consideration of the Council on the 19th April last, namely the terms on which a lease of ground in the Bullring could be obtained from the landlords thereof, The Honorable Mrs. Deane Morgan and Lord Muskerry. Messrs Little & Nunn said that as the Council were not disposed to acept a new lease on the conditions stated the landlords thought it best to let things remain as they were for the present.

Under the circumstances it was unged that the Council would be secure enough to build under the terms of the existing lease, as there was every likelihood that before the lapse of many years the principle of fixity of tenure in the case of tenants of twon holdings would be established by law. There was nothing practical done however.

with regard to a proposal of the Council to treat the sprface of Spawell Road and of Redmond Road with a Mechanical Steam Roller, a letter from Mr. Lyne, Secretary Wexford Gas Company, was read. He stated that in the interest of the Company, his Directors regretted that they were obliged to object to the intended work being gone on with, in so far as Spawell Road was concerned, and requested that the Order dealing with that road should be revoked.

With reference to minutes of 6th Ultimo, it was announced that the Finance and Works Committee had had before them an account of the receipts and expenditure in the last financial year in respect of all the dwellings provided under the Housing Acts in Wexford. Among the bills passed this day for payment was one of £45. 16. 11 being balance due to the Town Surveyor for services rendered by him in connection with a Scheme which was carried into effect by the Council under the Housing of the Working Classes Acts. The sum mentioned included an item of £9. 12. 6 which was the Surveyor's commission on the outlay incident to the laying of footpaths and water mains and the opening of sewers in connection with the houses. Alderman Walsh and Councillor Prendergast objected to the rayment of this last named sum on the ground that if the houses had been provided by private enterprise no commission would be payable to the Surveyor in respect of footpaths, watermains, or sewers. It was pointed out however, that the Finance and Works Committee had considered this perticular item and recommended it to be paid inasmuch as the sexford Borough Council Scheme formulated by

the Council and approved by the Local Government Board.

With regard to minutes of proceedings of 5th July last, Councillor O'Connor, on behalf of Alderman Hanton, moved the revocation of all resolutions dealing with the rents of 75 of the dwellings provided by the Council, namely 26 situate in Roche's Road and Carrigeen, 12 in William Street, 22 in Distillery Road, 8 of the smaller-sized houses on the West side of Carrigeen and 7 in Monument Place.

The motion was seconded by Councillor McMehon and was passed unanimously.

Thereupon Councillor O'Connor proposed a motion to the effect that a reduction of twopence per house per week be made in the rents up to the present charged for the 75 houses referred to in the foregoing resolution.

The motion was seconded by Councillor Carroll and was passed.

A question was then raised as to the justice of making a like concession to the tenants of the 7 houses in Grogans Road and the 2 larger-sized houses in Carrigeen.

These 9 were the only ones out of all the dwellings provided by the Council in which a reduction of rent had not been made.

This being so, Councillor prendergast gave notice that he would move at next Statutary Meeting of the Council that the resolution whereby the rents of the 9 houses referred to were fixed should be rescinded with a view to a reduction of rent in these cases being granted.

In relation to the proceedings of the Council on the 9th Instant, on which occasion notices of motion were received from the Mayor regarding the advisability of the Council providing fifty additional dwellings under the Housing Acts and formulating and carrying to completion a Scheme of main drainage for the town, His Worship introduced the subject of increasing the housing accommodation for the working classes. He maintained that the number of healthful houses to be had by these classes was altogether inadequate,

The subject was given a lengthened and serious consideration with the result that the following motion, as proposed by the Mayor, and seconded by Councillor Clancy was adopted.

That this Council take immediate steps towards the erection of fifty houses under the Housing of the Working Classes Acts, provided they can be built at a cost which will ehable the Corporation to let them at a rent not exceeding 2/6 a week, and that if necessary a provisional Order be applied for to permit the Council to take ground by compulsion for the purpose.

It was decided to refer the subject of the foregoing resolution to a Committee of the Council with a view to seeing if it were possible to provide houses which could be let at 2/6 each per week without causing any loss to the retepayers.

The mayor then submitted a motion committing the Council to a definite decision to provide and carry out a main drainage system for the town. In advocating the proposal he suggested that a sum of £4,000 should be raised by way of Loan for this purpose. This sum, he admitted, was not sufficient but it would be enough to permit of a modern system of sewers being opened in these parts of the town where the lavels were such as to render the existing sewers inefficient, but after careful consideration of the question, the meeting came to the conclusion to adopt the following motion, as proposed by The mayor, and seconded by Alderman Sinnott.

That this Council shall refer to a Committee of the Corporation the question of extending the Main Drainage System of the Town.

Included in the Accounts passed this day for payment was a Bill of £5. 8. 6 from Patrick Foley being compensation demanded by him for loss of bedding and articles of wearing apparel destroyed by the Sanitary Sub-Officer. Thereupon Councillor Prendergest proposed that the rents charged at present for the nine dwellings in question be reduced by twopence per house per week.

The motion was seconded by Councillor Clancy and was passed unanimously also.

A communication from the Local Government Board was read under date of 8th August 1911, No.53,803. The Board in adverting to the minutes of Proceedings of the Council on 2nd. August 1910 required to be informed whether the Council intended to make the appointment of the Veterinary Inspector under the Dairies &c. Order a permanent one or for only another year.

Councillor McMahon proposed that the office of Veterinary Inspector to assist in C: Wexford Borough Council administering the Dairies &c. Order 1908 in the Urban District of Wexford be hereby

The question of renewing the appointemnt of the Veterinary INSPECTOR under the Dairies &c. Order, Cos Wexford Boroughs Gouncine to at last meeting,

was considered with the result that on the motion of Alderman Hughes, seconded by Councillor O'Brien, the following motion was adopted, Councillor Prendergast dissenting.

That Mr. Francis Staples, V. S., be re-appointed as Veterinary Inspector to assist in administering the Dairies and Cowsheds Order 1908 within the Urban Area of Wexford for one year from this date.

Five tenders received in respect of doing the printing work of the Corporation for one year were opened. Four of them proved to be from the following Firms, namely, W. Hanrahan, Wexford, The People Printing Works, Wexford, J. Newman & Son, Wexford, and John English & Co. Wexford, but the fifth did not disclose the name of the person or Firm by whom the tender was sent in and was not therefore considered. With regard to the tender from J. Newman & Son, a question was raised as to the desirability of entertaining it, having regard to the fact that this Firm had refused last year to do certain printing work in respect of which their tender had been accepted.

Councillor Kingsberry thereupon proposed that the tender of Messrs J. Newman & Son be not entertained.

The motion was seconded by Councillor Clancy and was adopted.

With regard to the tender from the Firm of John English & Co., a question was also raised as to the justice of entertaining it. It was alleged that this Firm did not pay their employes in accordance with what was recognized to be the standard rate of wages adopted in the District, and it was pointed out that one of the conditions under which tenders were to be accepted was that intending Contractors should be prepared to submit to the requirements of Resolutions of Council of 3rd. July 1899 and of 2nd. march 1903, whereby the principle of "fair wages" was to be recognized. Of the truth of the allegation there was no evidence adduced, but nevertheless, it was resolved on the motion of Councillor O'Brien, seconded by Councillor O'Connor to not entertain the tender of Messrs John English & Co.

By the foregoing proceedings the number of tenders deemed to be acceptable was reduced to two, namely that of The People Printing Works, and of W. Hanrahan. It is needful here to state that another condition on which tenders were to be sent in was that the cheapest item in each tender was to be accepted.

The meeting then went over the items contained in each of the two tenders seriatim and marked such items as proved to be the cheaper "accepted".

In respect of the intended laying of a water main in William Street, as to which piece of work tenders were invited by advertisement there was but one tender received. This was opened and found to be from John Browne, Builder, Henrietta Street, Wexford. The would-be Contractor offered to carry into execution the terms of the specification of the work in consideration of being paid a sum of £27. The estimate prepared by the Town Surveyor of the cost of the work was thereupon referred to and was found to amount to £24. and on the motion of

Councillor O'Brien, C: Wexford Borough Council pted.

Allusion was made to the circumstance of the lock-out which occurred some weeks back in the three local agricultural implement factories, and as a result of which there was considerable distress among the section of the workers of the town who had been deprived of their employment. It was suggested that in all cases where the persons affected by the lock-out were occupiers of dwellings provided by the Corporation the meeting should decide to forego the rents during the continuance of the dispute between employer and employed. The legality of adopting this suggestion was called into question, and after due deliberation the following motion was adopted:-

Proposed by Councillor Clancy, seconded by Councillor McMahon.

That the Collector of Corporate Property be instructed not to press any of the Corporation tenants in the possession of small dwellings, and formerly employes in the Foundaries.

Regarding the present lamentable lock-out, whereby hundreds of families of the workmen recently employed in the three Firms of Ironworkers in the town were bereft of their means of livelihood, an appeal was made to the meeting by some members to make an endeavour of some sort to bring about a reconciliation between workmen and employers. All present fell in with the suggestion at once, and the result was that the entire members of the Corporation were appointed a Conciliation Committee to take any steps they thought wise, with a view to composing the dispute, if possible, and that the first meeting of the Conciliation Committee be called for this evening at 7. 30. P. M., the Town Clerk volunteering to act as Hon. Secretary.

Included in the Accounts passed this day for payment was an item of 13/- awarded to Mrs Johanna Doyle of Common Quay Street. The water supply to Mrs. Doyle's premises having stopped she had the ground in front of her house opened and the service pipe examined at a cost of 13/-. Mrs Doyle's plumber found that the "plug" of the water main which was the property of the Corporation, had become choked and the Corporation Turncock was witness to this fact.

The following is a copy of a letter read from the Under Secretary, Dublin Castle, in reply to a resolution of a Committee of the Corporation passed on the 25th October 1911. The Committee requested His Excellency, The Lord Lieutenant, to withdraw from the town the Ex tra police Force which had been stationed there consequent on the public excitement attending the "lock-out" that had taken place in three of the local Implement Factories on the 26th August last.

"With reference to your letter of the 26th Ultimo, I am directed by the

Lords Justices to acquaint you, for the information of the Municipal Council of

Wexford, that, in the opinion of the responsible police Authorities, the Extra Police Force now doing duty in Wexford cannot be reduced."

Att ention was called to the unprecedented arrears of rent which had accrued due on working class dwellings. Since the "lock-out" had occurred the arrears had increased from £19 odd, which was the normal amount outstanding on foot of these rents, to £52 odd due up to the present. The increase in the arrears was wholly owing to the fact that 26 of the men affected by the "lock-out" were resident in the working class dwellings and had not been pressed for rent pursuant to instructions of the Corporation. A discussion arose on the subject. The meeting not only showed disinclination to take action, but adopted the following resolution as proposed by Councillor Clancy and seconded by Councillor O'Brien. Applications received from occupiers of two of the newly erected working class dwellings at Distillery Road were read claiming compensation for damage done to furnitute. One of the applicants, mary Howlin, claimed £2. 5. 0, and the other, Annie Davis, 11/-. It appeared that the ceilings in one room of each of the houses occupied by the claimants fell down in a mass and broke and damaged furniture to the value of the sums demanded. According to the Town Surveyor's report he had found that the key of the ceilings had become, more or less, broken, and caused the plaster to give way. He had seen the broken furniture. He had also seen the builde r of the houses who satisfied to put up fresh ceilings at his own expense, although the term of his Contract had expired for many months. The Town Surveyor had no idea of the exact value of the furniture, but he was led to believe that one of the claims, that for £2. 5. 0 was too high, and that the claim for 11/- was about fair. With regard to the claim of Mrs Davis for 11/- it was ordered that it be paid in full out of the Borough Fund, but in the other case it was decided on the motion of Councillor Kingsberry, seconded by Councillor McMahon, to pay £1. 10. 0 as compensation for the damage done.

Tenders having been invited at the instance of the Finance and Works Committee in respect of supplying a Drain Clearing Apparatus, it was seen that only one tender had been received in response to the invitation. This was from Mr. M. Harpur of Main Street, and on being opened showed that Mr. Harpur was prepared to supply the brush in conformity with the specification of the apparatus for a sum of £9. 7. 6 if of English manufacture, and for £9. 12. 6 if required of Irish make.

Thereupon on the motion of Councillor Hore, seconded by Councillor O'Connor it was Resolved:— That the offer in respect of an Irish-made Apparatus at the price of £9. 12. 6 be accepted, having regard to the principle by which a preference is given to articles of Irish manufacture where price and quality admit.

An application from the Wexford lecture Association for additional seating accommodation to be provided in the Town hall was read and was referred to the Town Surveyor to report thereon, and particulars were requested to be furnished of all furniture supplied to the Town hall within the last ten yeears.

Included in the Accounts passed this day for payment was an item of £1. payable to Mrs Esther O'Neill of 13, Carrigeen Street. Mrs O'Neill claimed the sum mentioned as compensation for damage done to articles of furniture, her property, in consequence of the ceiling of the house which she occupied having fallen in a mass, the house in question being one of the buildings newly provided by the Corporation for the accommodation of the working classes. The claim was made to the Finance and Works Committee who had satisfied themselves that the furniture had been broken and recommended the compensation to be paid.

Mr james Sinnott by letter dated 10th November 1911 tendered his resignation as

Alderman for St. Iberius Ward. He stated he had taken this step as a protest

against the action of the Finance and Works Committee in connection with the matter

of the pollution of Che water the Folly Spout. Town Surveyor and himself

had been appointed to make the best terms possible with Mr. murphy for altering the course of a channel from the latter's malthouses. They had agreed with Mr. Murphy that he should supply the pipes and the Corporation have the work of laying them done at public expense, but the Finance and Works Committee repudiated the agreement, so placing him (Mr. Sinnott) in an invidious position, and one of the Members, Alderman Walsh, imputed the charge of backsliding in the matter.

The question was deliberated upon, with the result that the following resolution, as proposed by Alderman Hughes and seconded by Councillor Carroll was passed unanimously.

RESOLVED: That Mr. James Sinnott be, and is hereby earnestly requested to recensider his decision to resign the office of Alderman for St. Iberius Ward which he has filled for the last seven years with credit to himself and benefit to the inhabitants of Wexford.

With regard to minutes of proceedings of 2nd. October kast, on which occasion a tender from the Firm of John English & Co. in respect of printing work to be done for the Council was rejected on the ground that this Firm did not pay their employes according to the standard rate of wages recognized in the District, a deputation, consisting of seven of the employes of the Firm in question waited on the meeting, and by request, were permitted to make a statement. They said that some of them were members of the Typographical Association, and others were non-members, but on the question of the Firm paying a fair rate of wages, there was a misapprehension. They assured the meeting that the wages received by them was according to the standard rate prevalent for compositors in the town.

The meeting took no steps in the way of reviewing the action of the Council on 2nd.

October last in connection with the rejected tender, but promised the members of the

Deputation that the information supplied by them would be remembered on all future

occasions when tenders in respect of printing would be under consideration.

The Department of Agriculture and Tooknical Instruction by letter deted 21st. November

The Department of Agriculture and Technical Instruction by letter dated 21st. November 1911, No. G. 4,400, communicated the fact that an Officer of the Department obtained on 28th October la t at Wexford Butter Market, four samples of butter for analysis.

The samples were duly submitted to the Public Analyst who certified that they proved to be pure.

The Local Government Board, per their letter of 29th November 1911, No.50,571, drew attention to an accompanying memorandum embodying a resoltuion passed by the House of Commons on 10th March 1909 on the subject of fair wages clauses in Government Contracts The Board was of opinion that Local Authorities should introduce into the contracts made by them, clauses on the lines of those inserted in Government Contracts, especially in cases where the expenditure of public money, granted by a Department of State, was involved.

The various clauses of the memorandum above-mentioned, having been read over and studied, they commended themselves to the meeting, and it was decided to include them, with modifications necessary to render them suitable to the requirements of Wexford,

in all future con C: Wexford Borough Council

The same Department, per letter of the 16th November last (No.45,616) referred to a proposal of the Council at their meeting of 23rd. August 1911, to carry out a Scheme of dwellings for the housing of the Working Classes and requested to be informed how the matter of the acquisition of lands required as sites now stood. This occasioned the opening of a discussion about the apparent injustice of the Government granting Loens for the provision of houses for the use of agricultural labourers in terms far more generous than for the provision of workmen s houses in towns. There seemed to be ample room for making a good case in behalf of Urban Areas on this point. There was an instance in Roscrea where a Rural District Council had erected a range of houses inside, or immediately adjoining, the Urban Area, and were in a position to let them at 165 each per week, whereas it was not possible to let houses for less than 3/- each per week without intruding on the pockets of the ratepayers in Wexford.

Aldermen Hadden thereupon proposed and Alderman Hanton seconded the following motion which was adopted.

That a Committee consisting of The mayor, Alderman Hadden and Hanton, and Councillors Carty and Mcmahon, be appointed to conduct inquiries and obtain information as to the best means of putting Workmen in towns on a footing of equality with Rural Labourers in the matter of Government Loans for housing purposes Tenders received in respect of supplying quarried stones to be broken for road metalling in the Corporation stone depot were received. They were from Moses Power of Kerlogue, who offered to supply 200 tons of stones according to a sample sent in by him at the rate of $2/7\frac{1}{2}$ per ton.

William Sullivan of Wexford who offered to supply 500 tons to be delivered at Carrigeen depot at 2/6 per ton, and 500 tons at Redmond Road depot at 2/7 per ton. The stones were to be of the one quality, but the difference in price was due to the fact that the Carrigeen depot was about a mile nearer the quarries than the Redmond Road depot.

Thereupen on the motion of Councillor Clancy, seconded by Councillor Goodisson, the tender of William Sullivan in respect of 2/6 per ton and in respect of 2/7 per ton was accepted.

About Moses Power's tender, it was suggested that in consequence of the difficulty experienced in and around Wexford of obtaining sufficient quantities of raod repairing material, that his tender should also be accepted, even although the price demanded by him was the highest asked. The question of accepting this tender was discussed, and the result was that the following motion was adopted.

Proposed by Councillor Browne, seconded by Alderman Hughes.

That the tender of Moses Power in respect of supplying 200 tens of stones be accepted on condition that he will agree to deliver half that quantity on or before 1st January next.

Tenders received in respect of supplying earthenware pipes to be used in connection with the work of cor Con Wexford Borough Council Ward, were opened. They were from Matthew Harpur of Main Street, Wexford, and george Stafford

of John Street, Wexford. The former offered to supply the quantity required according to the sample sent in at a price per yard which would amount to £18.6.0, and the latter was satisfied to supply the quantity required according to the sample sent in by him at a bulk sum of £14.9.6.

Both of the samples having been examined by the Town Surveyor and found to be of good enough quality for the purpose needed, the following motion was adopted.

The stonebreakers employed by the Corporation under the superintendence of the Town

Surveyor made an application in writing for an increase of the rate of the remuneration

ton for "powdering" stones to such a size as would allow any individual "powdered"

stone to pass through a 2 inch ring, but for the special purposes of the Town Surveyor

he required them now to be broken to such a size as would allow any stone to pass through

a ring of 12 inch diameter. The applicants maintained no stonebreaker was capable of

"powdering" more than one ton of the smaller-sized stones in a day. They asked that in

respect of breaking the smaller-sized stones their rate of remuneration should be

increased to 2/- per ton.

On the recommendation of the Town Surveyor the request was granted.

The Report of the Local Government Auditor, Mr. J. More O'Ferrall, of his examination of the Municipal Accounts of Wexford for the year ended 31st march 1911 was submitted to the meeting, a copy of it having been received from the Local Government Board per their letter No.62,875:1911. An Abstract of the Accounts accompanied the communication. The Report did not evoke any comment as it contained no criticism of the financial operations of the Council for the year in question.

With regard to minutes of proceedings of the Council on 4th Ultimo, a letter was read from Alderman Sinnott. He stated that in deference to the wishes of the members of the Corpora ion, and at the request of several influential ratepayers, he begged to withdraw his notice of resignation of the Office of Alderman for St. Iberius Ward.

Pleasure was expressed at this action on the part of Alderman Sinnott.

The Wexford Harbour Commissioners, per letter from their Secretary, intimated that they had issued instructions to the Gas Company to discontinue the lighting of the public lamp immediately outside the Fishery Landing and also lamp in Selskar Street at the corner of Ram Street. Thereupon on the motion of Councillor Ffrench, seconded by Councillor Prendergast, the recommendation of the Finance and Works Committee was adopted.

Complaints were made by members about the inattention which the Gas Company had been giving tothe public lighting of the town. It was stated that a lamp had been taken down in Mary's Lane which had been erected on a lately demolished Malthouse and had not been re-erected, also that proper attention had not been given to the lighting of lamp at head of mary's Street and lamp at the Gate of the Fever Hospital. It was also reported that lamp at corner of King Street had been extinguished at 5. 25 o'clock on Christmas Morning by the Gas Company's lamplighter.

Ordered: That the Gas Company be written to and requested to require their employes to pay due attention to the lighting arrangements of the streets in future.

Mr. Laurence McCarthy of Charlotte Street, by letter complained of the continuous filthy condition of portion of Trimmer's Lane. The laneway seemed to him to be a depository for heaps of filth.

This matter was referred to the Finance and Works Committee.

Attention was called to the disused ventilating lamp situate in the Bullring. The Gas Company had refused to continue the lighting of this lamp, owing, as they alleged, to its being the cause of an explosion in an adjacent main sewer with which the lamp was connected, and for which it served as a ventilator. Since this light had been extinguished, the street after dark was lighted in a very inefficient way, and it was necessary that a lamp of some kind should be provided in the place.

The eupon it was ordered: - That the gas Company be requested to convert the ventilating lamp in the Bullring into an ordinary gas lamp and keep it lighted as an ordinary street lamp.

seconded by Alderman Hanton, the following motion was submitted, viz:

That Howard Rowe Esq., our present mayor, be, and is hereby, elected Mayor for the year commencing this day, and until his Successor be appointed and shall have accepted Office.

Before the question was put Councillor Prendergast protested against the act of electing a Mayor being gone on with on the grounds that what he beleived were the rights of the mayor of Waxford had been ignored by the Government in the matter of drafting an extra Force of Police into Wexford and keeping them there since August last, without the opinions of the Mayor having been consulted. He had no personal objection to the present worthy occupant of the Cicic Chair being elected. Thereupon several Councillors spoke in favour of the motion, paying a high tribute of praise to His Worship, The mayor for the manner in which he had discharged the onerous duties which fell to his share for the last year, which was an exceptionally disturbed period in the history of Wexford owing to the labour troubles which had sprung up in the town, and unfortunately yet remained unsettled.

Thereupon the motion was put and it was passed with acclamation, there being only the one dissentient voice.

The Mayor on signing his Declaration of Acceptance of Office returned thanks for his re-election. He said he had no particular desire to fill the Office of Mayor nor would be have accepted it, were it not for the influence brought to bear on him by the members of the Council. He took occasion, inter alia, to express a sincere hope that the cloud which was hanging over the town would have passed away and peace and prosperity be restored to it before long.

It was resolved that the three quarterly Meetings of the Council to be held previous to 15th January 1913, he fixed to be held on Monday, 6th may 1912, at noon, Wednesday, 7th August 1912 at helf past seven o'clock p. m., and Monday, 4th November 1912 at helf past seven o'clock p. m.

Thomas Hore, The Superior of the Christian Brothers Wexford, and Messrs Joseph S. Thompson, Richard Walsh, and Patrick Hanrahan.

On the motion of Councillor Carroll, the following Order was passed unanimously That we, the Wexford Corporation in public meeting assembled, do hereby condemn in the strongest manner the sale of immoral newspapers in the streets on Sundays.
