Dublin. 1st June 1899

Sir

I am directed by the Local Government Board for Ireland to acknowledge the receipt of your letter of the 24th ultimo requesting sanction to a proposal of the Co. Council of Wexford to transfer the amount standing to the credit of the former Grand Jury of Wexford, with their Treasurer the Provincial Bank, to a new account to be opened with the National Bank in the name of the Co. Council and in reply I am to state that the Local Government Board do not see any objection to the course proposed by the County Council with regard to the sums mentioned in your letter. Any claim on the balance of the account of the former Grand Jury by both Co. Councils can be dealt with in the adjustment of accounts of these bodies

Sessions House at Arthurstown

Sir

I am directed by the Local Government Board for Ireland to acknowledge the receipt of your letter of the 25th Inst. relative to a loan for the purpose of building a Sessions House in Arthurstown, and in reply I am to state that article 22 (II) (B) of the Local Government (Application of Enactments) Order 1898 provides that the County Council may with the consent of the Local Government Board borrow for "purchasing any land or building, and building which the Council are authorized by any act to purchase or build"

It is provided by section 59 of the Grand Juries (Ireland) Act 1836 as adopted "that it shall be lawful for any County Council to resolve that such sum or sums of money shall be raised off such County as shall be necessary for building, rebuilding, enlarging, repairing, altering, or fitting up any court house or Session House therein."

The following Resolution passed by the Co. Wicklow Co. Council was read & adopted -

Wicklow Co. Council

30th May 1899

Resolved: That recognising as we do the urgent necessity that exists for the establishing of a Board of Agriculture in Ireland in thorough sympathy with the Agricultural and Industrial interests of this ~~country~~ ^{country} and under popular control, we strongly disapprove of the bill for the establishment of

a Department of Agriculture, introduced by the Chief Secretary, as it in no way fulfils such conditions - its provisions being entirely of an autocratic character, the suggestion of a popular voice in its working being altogether illusory.

We also condemn its financial provisions, which we cannot, but characterize as grossly unjust as we consider Ireland is entitled to have funds necessary for the administration of such a measure as this remitted to her out of the £3,000,000 a year she is still being unjustly deprived of.

in Parliament We therefore call upon the Irish Representatives in Parliament to urge upon the Government such modifications of the measure as will satisfy the demands of justice, good Government and efficient administration.

That copies of this resolution be printed and forwarded to the Leader of the House, the Chief Secretary, Captain Donelan whip of the Irish party, and to each of the County and Borough Councils in Ireland, with a request to those bodies to adopt this or a similar resolution.

Grant to Industrial Schools.

The following letter received from the Manager of St Michael's Industrial School, wexford was read and the matter reported on was referred to the Finance Committee.

St Michael's Industrial School
Wexford 2nd June 1899.

Gentlemen,

Before sending in our account from 30th November 1898 for maintenance of County Wexford children in this school I would respectfully ask you to take, into your consideration the inadequate amount of the payment made to us, for the past few years, and to increase same to such an amount as will be equal to the rate per child per week, paid us by other counties.

The original agreement made with us by the Grand Jury of this County was 2/6 per child per week, and on the faith of this agreement, we expended, very large sums in providing suitable accommodation for the children to be committed to our school.

This payment was however reduced from time to time, in face of our protests and for the children committed to us in this County for the past few years we only received 1/- per child per week, while ^{for} 11 or 12 old Committals

Commitments we received only 1/- per week. Although this reduction was made in case of the County Wexford Industrial Schools the Grand Jury continued to pay 2/- per week to Arane and other Schools outside the County. We have children here from many other counties in Ireland; from the County Kildare we receive 2/- per child per week.

On referring to the Inspector's last report on Industrial Schools in Ireland, the County Council will find that the actual annual cost of the maintenance of each child in this school was £19. 17. 6 so that a payment of 2/- per child per week, in addition to the Government Grant of 5/- per week, would still be under the actual cost.

Under all the circumstances and taking into account the fact that the money granted to our School is spent in the County, we venture to hope for a favourable consideration of our application.

Collectors Security

Notice of motion by Mr Browne to rescind the resolution naming £500. as security of Poor Rate collectors and their sureties, and that the security be £300 each was received.

Collectors Remuneration

Proposed by Lord Maurice Fitzgerald Seconded by Mr Browne and passed That the Secretary write to the Local Government Board drawing their attention to the manner in which Poor Rate Collectors would receive their remuneration as set forth in Article 12 of Local Government Order, No. 161 M. 1899. which states:-

"Every Collector of the Poor Rate shall be remunerated for his services according to the following scale. (1) On all moneys collected and lodged within four months after he shall have received his Warrant, such poundage rate as the County Council with the approval of the Local Government Board shall have fixed" (2) On all moneys collected and lodged after the expiration of the above mentioned period but within the financial Half year. one half the said poundage rate. and pointing that this scale of remuneration seemed to be unworkable for the reason that the Poor rate is collectable half yearly and considering that it would be 2 or 3 months after the beginning of each half year before the Collectors would receive their Warrants, till the end of the financial Half Year. which the Collectors considered a great grievance as they could never earn the full amount of their poundage, and asking the Local Government Board to make such change as they deemed desirable.

Ordered: That the matter of appointing 2 Poor Rate Collectors instead of Mr. Donald in the "Enniscorthy Union" and Brinslaw in the "Gorey Union" who refused to act be referred to the Finance Committee.

Appointment of Accountant

Ordered: That the applications for the position of temporary accountant be sent in before 15th and that applicants attend personally at Meeting of Finance Committee on that date.

Collectors Sureties

Proposed by Mr Peacocke Seconded by Lord Maurice Fitzgerald:- That the Poor Rate Collectors Sureties should attend before the County Council for examination as to their solvency. Passed
