Ballyhack Arthuistown, via Waterford March 9th 1903.

Sir

I received the inclosed notice. I am strongly against the change believing as I do that it is against the interest of the bontractors, as nearly all of them are poor small farmers and the quarterly payments are a great benefit to them. Since we went into office under the L. G. Bill several contracts have been taken and they wont expire until 1906. In view of that fact I would like to have your opinion on the matter and let me know whether a change or not can be made. I would be glad to know also if the change was made would the salaries be altered.
