

Quarterly Meeting - 5th May 1903.

The Statutable Quarterly Meeting of the County Council, was held in the Council Chamber Court House, Wexford, on May 5th 1903.

Present - In the Chair, Mr. E. Horrigan chairman other Councillors - Messrs D. Dempsey, J. E. Taylor, M. Browne, J. Donohoe, J. Bolger, J. Cummins, A. Kinsella, M. J. Furlong, R. King, D. Kavanagh, J. B. Hearn, J. Sinnott, J. A. Doyle, C. H. Peacocke, J. Shearne, J. J. Walsh, J. Bolger, J. Gadd, M. Hickey, J. D. Doyle, M. A. Ennis, and Lord Stofford

The Secretary (Capt. Pigott), Mr. Elgee solicitor to the Council, and Mr. Webster, County Surveyor were also in attendance.

The minutes of last meeting were read and confirmed.

On the motion of the Chairman the standing orders were suspended to allow of him to move a resolution.

Obstruction at Hesaly Bridge.

The Chairman moved - That the County Surveyor be directed to write to the Manager of the G. Southern and Western Railway Company, with reference to the obstruction which was caused to traffic at Hesaly bridge, Killinick on the morning of May 5th by a traction engine and several waggons of the company being drawn across the road. In consequence of this obstruction a number of people with vehicles were delayed for over an hour at this place. That a copy of the letter of Mr. Webster, and the reply of the Manager of the Railway Company be laid before the next meeting of the council.

Mr. Dempsey seconded the resolution which was passed unanimously.

Transport Development Committee Arising out of the minutes of last meeting Mr. Ennis explained the steps which had

been taken by the Transport Development Committee to induce the promoters of the Transport Development Scheme to include Rosslare as a central depot.

W^r Peacocke moved - "That the Transport Development Committee of the Council be re-appointed, and that they be empowered to prosecute negotiations with the Great Southern and Western Railway Company of Ireland, and the Great Western Railway Company of England, and to carry out such steps as they may consider desirable with a view to the promotion of the wishes of the Council in the matter of the Development Scheme."

W^r J. D. Doyle seconded the resolution which passed without dissent.

The late Councillor Ryan.

On the motion of W^r Peacocke, seconded by W^r Dempsey the following letter was ordered to be inserted on the minutes -

Co-option of councillor.

The Chairman proposed that Mr. John J. Kehoe Main Street Wexford, be co-opted a member of the council in the room of the late councillor Ryan.

Mr. Ennis seconded the motion.

Mr. Cummins proposed the election of Alderman Blaney, Mayor of Wexford.

Mr. J. B. Hearn seconded.

In connection with the question of the co-option of a member the following resolution was received from the Wexford Corporation -

Proposed by Councillor Wm. Mangan,
seconded by Councillor J. Bulfinmore.

Resolved - That as a vacancy has occurred in one of the two offices of County Councillor for the Urban District of Wexford, and as the duty will devolve on the County Council to fill the vacancy by co-option we respectfully suggest to the members of the County Council the propriety of co-opting the present Mayor of Wexford as representing the Borough."

Mr. J. J. Walsh, County Councillor, who was not in attendance for this portion of the proceedings wrote that he thought any member put forward by the public body representing the District ought to have a claim on the votes of the County Council.

A poll was taken with the following result.

The chairman declared Mr. Kehoe co-opted.

be appointed a member of the Finance
Committee of the County Council, a member
of the County Wexford Infirmary Committee
a member of the Asylum Committee, and a
member of the County Wexford Committee
of Agriculture and Technical Instruction
in the room of the late Councillor Ryan.
Mr. Peacocke seconded the resolution which
was passed *unanimously*.

Striking the Rate.

On the motion of Mr. Peacocke, seconded by
the chairman the following recommendation
of the Finance Committee was agreed to -
Proposed by Mr. Browne, seconded by Mr. Durlong
that we recommend the Council to strike the
Rate for General and Separate charges for
the financial year ending 31st March 1904.
That we seal and sign the Rate Books,
and the Warrants of the Collectors."

 All the candidates were in attendance with the exception of John O'Connor. They were questioned by the Chairman, and stated that they had read the advertisement and were satisfied to comply with its conditions.
 Mr. W. J. Furlong proposed and Mr. Browne seconded the appointment of Patrick Dunne.
 Mr. J. Bolger proposed and Mr. J. D. Doyle seconded the election of John Sinnott.
 Mr. Hearn proposed and Mr. Ahearn seconded the election of Martin Doran.

Mr. Dempsey proposed and Mr. Hickey, seconded the appointment of Moses Sutton.

Mr. Walsh proposed and Mr. Kinsella seconded the election of Patrick Fortune.

Lord Stopford proposed and Mr. J. A. Doyle seconded the appointment of John Mullett.
 None of the other candidates were proposed or seconded.

Previous to his election, Patrick Dunne, in reply to Mr. Walsh, stated that his age was 20 years and four months.

Mr. Elgee said he considered that it was not legal to appoint a minor to the position.

Mr. Browne pointed out that the applicant was the son of the late collector, had been discharging the duties for the father, and would in a few months be of legal age.

Claim by Dr. Murphy, coroner. A claim for £18. for holding inquests outside his district on the requisition of the police was received from Dr. Murphy, coroner for North Wexford.

Letters from the Local Government Board No. 7,543/1903. Wexford County, under date 10th Feb. 1903. No. 11,825/1903. Wexford County under date 27th Feb. 1903, and No. 15,663: 1903. Wexford County under date 20th March 1903. on the claim of Dr. Murphy were read.

W. Hearn proposed and W. Codd seconded that the following recommendation of the Finance Committee, on the matter be confirmed:-

Proposed by Mr. Furlong, seconded by Mr. Browne
that we pay Dr. Murphy, coroner, a sum of £8.
for holding four inquests outside his district
at the rate of £2. per inquest, and which
were held on the requisition of the police.
That our Secretary inform Dr. Murphy that the
section of the Act of Parliament has been
repealed allowing mileage, otherwise the council
might have allowed the amount.

Qualification of Mr. D. Dempsey as councillor. Under date 10th Feb 1903, the Local Government Board, (letter No. 10,0313, 1903 Wexford County) wrote that in the circumstances of the case of Mr. Dempsey they had been advised they have no power to make an Order for a new election under article 7 (v) of the Schedule to the Local Government (Application of Enactments) Order 1898.

On the same subject Mr. R. W. Elgee, Solc. to the Council wrote under date 21st Feb. 1903.

"I am in receipt of your letter of the 20th Inst., with a copy letter from the Local Government Board as to Mr. D. Dempsey's case, but it appears to me that the Board have entirely overlooked the fact that Mr. Dempsey was not eligible for election in the months of June last, and that consequently his election was void from the beginning, but of course if the Local Government Board, are satisfied, that he is still a member of the Council, I don't see that the Council need take any further notice of the matter. I think however Mr. Dempsey should sign a new declaration."

The Secretary said that acting on the advice of their solicitor, Mr. Dempsey had made a new declaration of Office.

Re-adjustment, Financial Relations between Council and Wexford Urban Dist. The Secretary read letter from the Local Government Board, under date 31st March 1903. (No. 17378, 1903) forwarding copy of draft provisional order altering the financial relations between

the Wexford Urban District, and the County Council, and explained that it carried out the agreement that had already been arrived at between the two bodies.

Extension of time for payment of debts. Circular letter from the Local Government Board, No. 22 M. 1903. Miscellaneous, under date, 19th Feb 1903, was read. This letter pointed out that the Local Government Board would enforce the provisions of section 51 (7) of the Local Government (Ireland) Act 1898, except in cases in which it is clearly proved to their satisfaction that there was a reasonable cause why the debt was not paid, or for not taking legal proceedings within the prescribed period.

On the motion of the Chairman seconded by Mr. Peacocke, it was decided that the terms of the Order of the Local Government Board be advertised in the local papers.

Regulations-Locomotives on Highways. Letter No 71677/1902, under date 9th Feb 1903 (Sealed Order, Amended General Regulations under the Locomotives on Highways Act 1896, was read by the Secretary, who explained that a copy of these regulations had been supplied to each member of the County Council.

Wexford Dist. Col. & state of roads- Letter No 15090/1903. Wexford Rural District, from the Local Government Board, under date 16th March 1903, was read.

The Local Government Board enclosed copy of Minutes of Proceedings of the Wexford Rural District Council of the 7th March, with a copy of the Local Government Board reply.

The County Surveyor explained that this matter had been settled. Orders had been obtained against the Railway Company, and they were carrying out the work of repairing the roads which had been damaged by them.

Closing accounts-Financial Half Year. Circular letter No. 42 M. 1903. Miscellaneous, from the

Local Government Board, under date 25th March 1903, was read. According to this communication the Local Government Board have decided to direct that all accounts both as regards receipts and expenditure, shall be closed and balanced for audit as at the end of each financial year, or, in the case of accounts required to be closed half yearly as at the end of each half year.

Order (Sec 12) Local Govt (I) act 1902

The following letter No 17920/1903 Wexford County, under date, 8th April 1903 was read from the Local Government Board.

"I am directed by the Local Government Board for Ireland to acknowledge the receipt of the resolution adopted by the County Council of Wexford at a special meeting held on the 23rd ultimo, proposing to adopt the system of half yearly meetings for the transaction of the business of the Council now dealt with at Quarterly meetings; and in reply I am to state that the Local Government Board have given directions for the preparation of an order under section 12 of the Local Government (Ireland) Act 1902, authorising the Council to hold half yearly instead of quarterly meetings. A draft of the order will be forwarded to the Council for their consideration in due course.

As regards the salaries of the County and Assistant Surveyors, the Local Government Board will be glad to learn the result of the circular issued by the County Council to the contractors, inquiring whether they will consent to half yearly instead of quarterly payments in respect of their contracts, before the Local Government Board proceed to deal with the question. The following recommendation had been made by the Finance Committee.

"That we recommend the County Council to inform the Local Government Board that

we have not yet received a reply from all the contractors, and when the Council is in possession of a full statement as to the views of the contractors they will again communicate with the Local Government Board. That we instruct our Secretary to correspond with the clerks of the Rural District Councils, and request them to draw the attention of their district councils to the resolution of the County Council on this subject."

Lord Stopford moved the confirmation of the minute of the Finance Committee with the following rider, "And that the Secretary to this Council issue a circular to the contractors who have not already replied as to whether they are in favour of continuing the quarterly payments, or would be satisfied to accept the amount due to them half yearly."

Mr. Hearn seconded the resolution which was adopted nem con.

Complaint by a Road Contractor. Richard Kelly, Road Contractor, Ballygalvert came before the meeting, and complained that although he had his road in good order some of his money had been detained by the County Surveyor.

The meeting having heard a statement from the County Surveyor, decided to take no action in the matter.

Representatives of the Press at Meetings. Sealed order from the Local Government Board No 18/ M. 1908. as to the exclusion of the representatives of the Press from meetings of public bodies was read.

Reports as to Audit of Accounts. Reports as to the audits of the accounts of Enniscorthy Union and District Council, New Ross Union and District Council, Wexford Union and District Council, and District Asylum, received from the Local Government Board were laid before the meeting.

Abstract of Mortgages - Board of Works

The Board of Works forwarded an abstract of the Deed of Mortgage entered into between them and the Wexford Rural District Council for a loan of £250, under the Labours (Ireland) acts.

Payment of Instalments of Loans.

The following circular letter from the Board of Works under date 23rd March 1903, No. 14338-02, was read.

"I am directed by the Commissioners of Public Works to state that it has been brought to their notice that there has been a failure on the part of the council to fulfil the undertaking with reference to punctual payment of instalments of their loans which was given by them before their last loan was submitted for the sanction of the Lord Commissioners of His Majesty's Treasury.

"The undertaking was to the effect that the instalments in repayment of the loan for which they were then applying, as well as of any existing loans would be remitted at the dates at which they became due viz - 1st May and 1st November in each year. Notwithstanding this undertaking it has been reported to the Board that the instalment due the 1st November 1902, was not brought to their account in the Bank of Ireland until the 6th November 1903.

The Board direct me to request that this circumstance may be brought under the notice of the council, and that it may be conveyed to them that it is most necessary that the undertaking given should be strictly observed, and that payment of the instalment on the 1st May 1903, and of all future instalments should be punctually made, as a second default would seriously affect the question of the granting of any further loans to the council".

The Finance Committee made the following recommendation on the matter.

Proposed by Mr. Browne, seconded by Mr. Peacocke.

that if the Board of Works forward their Receivable Orders in time for the Quarterly meetings of the County Council, which are held on the first Tuesday in each February, May, August and November, they will be paid. That this fact has been brought to the attention of the Board of Works on at least two occasions, and we would point out to the Board of Works that we are precluded from making payments of this nature except at a quarterly meeting.

We consider the threat of the Board of Works in their circular letter No 14,5338 as entirely unwarranted and uncalled for, in face of the promise of this council to pay these Receivable Orders, whenever they come to hand in time to be dealt with at a quarterly meeting.

Mr Dempsey moved, and the chairman seconded the adoption of the recommendation of the Finance Committee
Passed unanimously"

Proposed Basin at Curracloe. The following letter under date March 7th 1903, from Mr Francis Killen, Ballyniskar Cottage Curracloe, was read.

"At a meeting held in Curracloe recently it was decided to bring before the County Council a proposal to build a Basin as shelter for the numerous fishing boats of this coast. I have been instructed to apply to you to get Mr Webster to inspect the place. I enclose you a map of the place and a rough sketch.

If Mr Webster would want any information about soundings etc, I can supply him, if he would kindly let me know what day he would call."

The County Surveyor stated that he had made a preliminary examination of the place, and he considered to make the proposed basin would be a very expensive work. He did not think that it was a suitable place for a harbour, and the question was, if a

more suitable place could not be procured higher up the coast.

"On the motion of the chairman it was decided that the consideration of the matter be postponed till Mr Webster makes an inspection of some other site, and his report thereon has received the consideration of the Piers Committee."

Claim - Excess Rate

The following letter was read from Mr J. Bolger Tivns under date March 13th '03

"I beg to apply to the County Council for the sum of £2 : 2 : 8½ amount of rate overlodged which I paid Mr John Walsh, on his last collection on increased valuation of my place to £60.

The present valuation fixed by the County Court judge being £38 : 10/- and the rating on this amount is £3 : 13 : 7."

The following recommendation of the Finance Committee on the above was confirmed on the motion of Mr Peacocke seconded by Mr Dempsey. -

Mr Peacocke proposed, Mr Donohoe seconded and it was passed - "That we refund Mr John Bolger, the sum of £2 : 1 : 10 excess rate charged in consequence of his valuation being reduced on appeal to the County Court judge from £60 to £38 : 10/-

Repairs - Courthouses.

The following recommendation of the Magistrates at Tivns Petty Sessions of the 4th March '03 was laid before the meeting.

"That we the Magistrates, sitting at Tivns Petty Sessions Court, consider there is a necessity to have the floor laid with cement and windows painted, and we request the landlord to bring the matter under notice of the County Council"

The following letter from Mr Joyce, Petty Sessions Clerk, Daghmon, under date 14th March was also laid before the meeting.

I beg to inform you that the recent

storm inflicted considerable damage on the outside of the courthouse, at Taghmon. Some slates were also blown from the roof and the building requires immediate repair. The Finance Committee recommended that these repairs should be carried out by the respective landlords.

On the motion of Mr. Hearn, seconded by Mr. Godd the recommendation of the Finance Committee was confirmed.

Road Contract of Philip Kelly-

Under date 13th April '08 the Town Clerk, New Ross Urban Council wrote that Philip Kelly was doing little or nothing with his contract within the Urban District, and in consequence the roads in his charge have worn very considerably. His council consider that some action should be taken by the County Council to have these roads put into order as the District Council should not take them over in their present condition on the expiration of Kelly's contract in July 1904.

Mr. Webster, County Surveyor stated that he had reported to the Proprietary Committee, the manner in which Philip Kelly was carrying out his contract. The difficulty in the case was that this was an old Grand Jury contract, and portion of the road was now in charge of the Urban District. He did not know if he had power to prosecute Kelly for the manner in which he was doing his work on this portion.

On the motion of the chairman it was decided to leave this matter in the hands of the County Surveyor, and that if he considers it necessary that he consult the solicitor to the council.

Collectors Somers & Smith - Change of Sureties. - Collector Edward Somers wrote that John Doyle, Moneyhore, one of his sureties had died, and offering the name of Thomas Furlong, of Dranagh instead.

Collector Smith wrote that Mr S. Richards one of his sureties wished to be relieved of his bond, and offering in his place, Thomas Smith, of Tara Hill.

On the motion of Lord Stopford seconded by Mr J. D. Doyle, it was decided to accept the names offered by both collectors.

Speed of traction engines-New Ross bridge. The following resolution was received from the Ida District Council:-

"We hereby request the County Councils of Wexford and Kilkenny, and the New Ross Urban District Councils to take the necessary steps to have the present by-law regulating the propelling of steam and traction engines across New Ross Bridge changed, so as to allow the propelling of engines by steam across said bridge in future at not more than two miles an hour."

Mr. Hearn proposed.- That we request the County Surveyor to meet the County Surveyor of Kilkenny at the New Ross Bridge, with one or two Councillors from the District, and consider the matter with a view to furnishing a report to the Council.

Mr. Shearne proposed.- That having heard the statement of our County Surveyor, that we take no action towards altering the present by-law.

Mr. Hickey seconded the motion, which passed.

New footpath- Enniscorthy Bridge. The following resolution was received from the Clerk, Urban District, Enniscorthy:-
That the Council consider that a new concrete footpath - 300 feet, with new granite kerbing requires to be laid down on Enniscorthy Bridge, North side, also that both walls of said bridge require to be pointed with cement mortar on sides and tops the (300 yards) cost of same not to exceed £56 : 18/- The Council respectfully request the County

Council to contribute half the cost viz £28 : 9/- this being a main road and the great necessity for the work being done.

The County Surveyor stated that he considered the work was very necessary.

The Secretary said that if this were a new work the Council should have some proof that Article 14 of the Urban Order had been complied with.

The County Surveyor said the work was one merely of maintenance.

Mr. Donohoe proposed - That as the application of the Enniscorthy Urban Council is for maintenance of an existing work we contribute half the cost, said contribution not to exceed £28 : 9/-

Mr. Peacocke seconded the resolution which was adopted.

Recompence jurors' payment -

Enniscorthy urban district -

The Clerk Enniscorthy Urban District wrote applying for a refund of £4 : 0 : 8. amount paid the Poor Rate Collector, of the Enniscorthy Urban District, for assisting in the preparation of the jurors lists for the year 1901. Letters from the Local Government Board no's 21,137, under date 15th April '03 and 22,845/1903. under date, 22nd April '03 on this subject was read.

The following recommendation had been made by the Finance Committee - Proposed by Mr. Kinella, seconded by Mr. Donohoe - That we refund the sum of £4 : 0 : 8. to the Enniscorthy Urban Council, payment made to the Rate Collector of the Urban District for assisting in the preparation of the jurors' lists for 1901.

Mr. Peacocke proposed, and Mr. Ennis seconded the confirmation of the minute of the Finance Committee. Passed.

Evicted tenants' Restoration Committee - The following letter under date, 28th Feb '03 was read from Mr. G. W. Russell, Hon Secy, Evicted

Evicted Tenants' Restoration Fund.

"In further reference to your letter of the 5th, if cheque for balance of funds on hands in Wexford is sent here payable to the Evicted Tenants' Restoration Fund, it will be lodged at once and our cheque sent to whoever may be appointed to receive it for an equal amount."

On the motion of the chairman it was decided to take no further action in this matter for the present.

County Wexford Féis

A circular was received from the Rev. P. Murphy M.S.S. Enniscorthy, asking for the support and influence of the County Council for the County Wexford Féis.

On the motion of Mr. Browne, seconded by the chairman the following resolution was adopted.

"That the object of the County Wexford Féis have our hearty sympathy and support. That we regret that we are not in a position to make a contribution to the funds of the Féis from the account of the County Council, but hope the councillors in their individual capacities will help the movement financially and otherwise."

Cheap Railway Fares.

Under date March 7th '03, the Secretary to the Dublin, Wicklow, and Wexford Railway Co. wrote that the application of the Wexford County Council for cheap rate tickets for members of the Council when travelling on County business was considered by the Irish Railway Managers when it was decided that the application could not be entertained.

Mr. Peacocke proposed - That our Secretary correspond with the Secretary of the Dublin, Wicklow, and Wexford Railway Company as regards giving facilities to teachers employed through the County Committee of Agriculture

and technical instruction by giving tickets on the same terms as are given teachers residing in the Dublin suburbs.

Mr. Ennis seconded the resolution which was adopted.

Lowest tender and wages.

A circular was received from the Irish tradesunion congress, stating that if the council adopted the fair wages resolution of the House of Commons, it was not necessary they should accept the lowest tender if the person making it would not agree to be bound by the fair wages resolution. No action was taken.

By-law. covered vehicles

A similar ruling was made in the case of a suggested by-law as to covered vehicles received from the cycling tourists' club.

Re-valuation of Ireland.

The following resolution received from the Mayo County Council was adopted on the motion of Mr. Browne, seconded by Mr. J. D. Doyle.

That this council view with alarm the proposals forwarded by Sir John Barton for the re-valuation of Ireland, recognising as we do the result would be the imposition upon this impoverished country of a further serious contribution to the British treasury, thereby adding to the monstrosous over-taxation of Ireland already existing. And we regard his ideas as to the valuation of Irish land especially as fraught with the most serious consequences to the agricultural interests of the entire country.

valuation Lists

Mr. Peacocke proposed, Mr. Ennis seconded and it was passed - That we agree with the resolution received from the Dublin County Council asking that the revised lists of valuation should be supplied at an earlier date than at present.

Amalgamation of Unions

Resolutions in favour of the amalgamation of

unions was received from the County Councils of Kilkenny and North Tipperary.

On the motion of Mr. Browne seconded by Mr. J. D. Doyle the following resolution was adopted -

"That we agree with the resolutions received from the County Councils of Kilkenny and North Tipperary as to the amalgamation of unions."

Town Rating

A resolution was received from the Strabane Town Council requesting that new buildings should not be rated for three years, but no action was taken thereon.

We consider his energy efficiency and courtesy to the public, entitle him to promotion, and we ^{now} desire to recommend Mr Parker to the favourable notice of the Postmaster General, with a view to his further advancement in the postal service. of the specimens of milk one was adulterated with at least 18 per cent of added water.

Two of the specimens of whiskey were 29 and 31 degrees under proof and were therefore adulterated with at least 6.53 and 8.1 per cent of added water respectively.

The remaining articles were of good quality. There were fifteen specimens of butter analysed by directions from the Department of Agriculture, Upper Merrion Street, Dublin which were taken up in the County of Wexford. They were pure.

For the Guardians of Gorey Union twelve drugs were analysed. One of them, namely, Compound Tincture of Gentian, was low in extract,

Two specimens of Easton's Syrup were very high in phosphoric acid.

For the Guardians of Enniscorthy Union nine drugs, namely Tincture of Cinchona, was low in alkaloids. Another, namely, Liniment of Potassium Iodide with Soap, was deficient in potassium iodide. The teas were of good quality.

In connection with this work the following letter and memorial was read.-

Re Fethard Pier.

Dear Sir.

With regard to the recommendation of the County Surveyor, to expend £45. on repairs to this pier, I beg to say that it is only five or six years since a sum of £28 was expended in repairing it, and now the County Council is asked to lay out £45. for the same.

purpose, and very probably in four or five years time a further sum of £40 or £50, will be required to do more repairs on it. Now, in my opinion, it is only throwing away money to be patching up this old pier. With regard to the statement of the County Surveyor that the sea wall is cracked and bulging, I am informed that it has been nearly in the same condition for the past 25 years, so that there does not appear to be any very great cause for alarm in consequence of this. I may point out that the Chairman of the County Council, and I believe Mr. French M.P. visited Fethard about two years ago in order to inspect this pier and the site proposed for a new one, and I understand that they entered into communication with the Chief Secretary, and the Department of Agriculture and Technical Instruction with the view of obtaining a government grant for the construction of it. It would therefore be well if the Chairman could now make a statement as to how the matter stands, because if there is any reasonable prospect of a new pier being built in the near future it is simply folly to be spending money on repairs to the old one.

I enclose a statement signed by the two District Councillors for Fethard and some of the fishermen, also protesting against this work, which you will please read for the Council along with this.

The Secretary said he had received the following letter from the Board of Works, under date, 1st April 1903 in connection with this point.

"I am directed by the Commissioners of Public Works, to inform you that it has recently been reported to them that some damage has occurred to the masonry work of Dethard Pier, County Wexford, and they would be glad to hear that the necessary work of repair and maintenance will be undertaken at an early date."

In the course of the discussion which took place, Mr. Browne pointed out that the idea in the minds of Mr. Turlong and the fishermen who had made the protest against the repair of the present pier was that a new pier would be built very soon, and that the present one should be allowed to fall. The County Council had no information that a new pier was even under the consideration of the Government, and if the council did not now take some steps to carry out the work which Mr. Webster, County Surveyor said was very

necessary the Council would have the Board of Works doing the work themselves at a very much enhanced cost.

Repairs - Barne Pier

No. 81 - To repair Barne Pier not to exceed £6.
To be a County at Large charge.

Referred to the County Surveyor, who is to have the work carried out.

In connection with this matter a letter was read from the Board of Works, under date 1st April 1903. as follows:-

"I am directed by the Commissioners of Public Works to inform you that it has recently been reported to them, that about 56 yards of concrete work on east side of Barne Pier, County Wexford requires repair, and pointing and resetting of coping stones near the end of the pier is also required. The Board would be glad to hear that the necessary work of repair, and maintenance will be undertaken at an early date."

Wexford Rural District - Roads.

No 79 - To maintain 597 perches leading through Churchtown, from Barne road not to exceed 7^d per perch.

Mr. Thomas Ryan, Ballytra Barne tendered at £17. 8. 0 (7^d per perch) and Mr. James Kearns, Ardounes at £12. 8. .8. (5^d per perch)

Mr. O'Connor, Solicitor who appeared for Ryan stated that his client's tender was the only one which came before the District Council, and it was rejected as it had not been signed by Ryan. He had offered at the District Council meeting to get the tender signed by Ryan, but the members of the Council would not consent.

In reply to the chairman, Mr. Webster said he considered that 5^d per perch was not an adequate price to keep the road. Kearns had not been a satisfactory contractor.

Mr. O'Connor said that he contended that the tender of Kearns had been

put in for an unfair purpose. Why did he not tender at the District Council meeting if he wished to compete fairly for the road, and not wait until he had seen the tender of Ryan.

Mr Peacocke held that as the road had been advertised for the County Council meeting the proceedings had to commence *de novo*, and he moved that the lower tender be accepted.

Mr J. D. Doyle seconded.

Mr Hearn proposed and Mr Shearne seconded that Ryan's tender be accepted.

On the motion of Mr. Peacocke, seconded by Mr. J. Bolger, the tender of Mr. Bullen being the lowest was accepted.

No 157A - To keep in repair 600 perches from Enniscorthy to Kiltrealy, between the turn to Galm, and the bounds of the baronies of Bantry and Scarrawalish.

John Roche, Kiltrealy, tendered at £37: 10/-

($\frac{1}{2}$ s per perch), Patrick Dunne, Caim, tendered at £35. ($\frac{1}{2}$ s per perch) and Joseph Bullen, Kiltrea, tendered at the same figure as Dunne.

The County Surveyor, said he considered that the road which had just been given Bullen, would keep him fully employed.

On the motion of Mr. Sinnott, seconded by Mr. J. Bolger, the tender of Dunne was accepted.

No 6. To build two gulleys at Courtmacuddy. There was no tender received and the work was referred back to the District Council.

Gorey Rural District - Roads-

The Secretary reported that the following tenders had been found unsigned.

Thomas Hendrick, Camolin No 3, Thomas Hendrick, Camolin No 5, No 71 Thomas Lawless, Ballywalterbeg, No 81 Patrick Dorian, Ballinastraw.

On the motion of the Chairman it was decided that these tenders be rejected on the advice of the Solicitor to the County Council.

No 4 - To construct a fence on the road to River-chapel. Referred back to District Council as no tender was received.

No 92 - To keep in repair 1226 perches between Kilmurry hill and the roads at Macoyle. Referred back to District Council, no tender being received.

New Ross Rural District - Roads.

The tenders of Michael Byrne, Semplundigan No A. and John Moran, Blonsharrow, No D. were found unsigned, and on the motion of the Chairman were rejected.

No A. was given in charge of the County Surveyor as Mr. Webster stated it was a work which would not admit of delay.

No 8. To keep in repair 65 perches between Fethard and New Ross. Referred back to District Council.

No 60. To maintain 744 perches, between Intern

and New Ross. Given in charge of County Surveyor, for the full period 11 months.

No 71. To maintain 694 perches, between Dallaghross and Taylorstown. Given in charge of the County Surveyor, for the full period 11 months.

No 1. - To rebuild the sea wall at Arthurstown pier. No tender was received and the work was referred back to the District Council.

Special Minutes-Lowest Tender. The Secretary stated that he had received from the Clerk of the Gorey Rural District Council special minutes as to the acceptance of tenders higher than others which had been received.

Repair of Road No 7. - Michael Ryan, Ballinrode tendered at £4: 10s. and John Doran Kilmuckridge at £5: 18: 9. The reason given for the acceptance of Doran's tender was because one of the sureties of the second person tendering was considered insufficient by the Council.

Road No 64 - Michael Ryan tendered at 6 $\frac{3}{4}$ per perch, and David Bran, Glone at 1/- per perch.

Ryan's tender was rejected as one of his sureties was not considered sufficient.

Road No 97 - Shore, tendered James Doyle, Tara Hill and £5: 12: 11 $\frac{1}{2}$; Thomas Byrne, Tomilla at £25: 18: 9; Patrick O'Neill, Ballingarry at £22: 16: 8., and Michael Keegan, Gorey at £19: 19: 7.

The tender of Michael Keegan was accepted as Doyle, whose tender was lower did not appear.

The Secretary stated that he had not received any forms of special minutes from any of the other Rural District Council Clerks.

District Councils-Proposals for Payment & New Works etc. That the several proposals for new works, renewals of contracts and for payments, for the current quarter, sent up by the Rural District

councils of the County, be approved, subject to the modifications and other orders noted thereon, and initialled by the Chairman, including provisional proposal to make a new road from White's Contract to the Barne River, from Wexford District Council. "Passed."
